AN ORDINANCE ANNEXING CERTAIN REAL PROPERTY
TO THE TOWN OF OAKLAND, MARSHALL COUNTY,
OKLAHOMA AS MORE PARTICULARLY DESCRIBED HEREIN



BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF OAKLAND, OKLAHOMA:

Section 1: The Town of Oakland, Marshall County, Oklahoma, desires to annex certain property to the corporate limits of the town. The Town of Oakland is an incorporated town.

Section 2: The property to be annexed is contiguous and adjacent to the present limits of the town and is not presently incorporated within the limits of the town.

Section 3: The consent of the owners of at least a majority of the acres to be annexed is not needed for the reason that the territory to be annexed is adjacent or contiguous to property already within the municipal limits and because the real property described below to be annexed is part and parcel of a platted sub-division in Marshall County, Oklahoma.

Section 4: Pursuant to the laws made and provided by the State of Oklahoma, including 11 Ok. St. 1991 §21-103, the real property hereinafter described may be lawfully annexed to the town and, henceforth, all purposes, considered a part of the town.

Section 5: That the following described real property and premises, situate in Marshall County, Oklahoma, are hereby annexed to the Town of Oakland, to wit:

Tract 1 a/k/a as Moore Acres Lot 14 on Map prepared by Marshall County Assessor for Oakland proposed annexing dated July 26, 2001 :

The S/2 of S/2 of N/2 of SE/4 of NE/4 and S/2 of SE/4 of NE/4 and NW/4 of NE/4 of SE/4 of Section 29, Township 5 South, Range 5 East, EXCEPT for all of the oil, gas and other minerals, in and under and that may be produced from said real estate.

Tract 2 a/k/a as Lots 1-14 on Map prepared by Marshall County Assessor for Oakland proposed annexing dated July 26, 2001 :

Lots 1-14 in the Quail Creek Addition, Marshall County, Oklahoma.

Tract 3, all of Brenda Avenue.

Tract 4, all of Red Bird Lane.


Tract 4, all of Sharon Avenue.

Section 6: The municipal services plan, attached hereto, is incorporated herein and made a part of this ordinance for all purposes.


Section 7: That there shall be filed in the office of the County Clerk of Marshall County, Oklahoma, a true and certified copy of this ordinance, together with an accurate map of the territory hereby annexed. In addition, pursuant to Title 11, Ok. St. §21-112 a duly certified copy of the ordinance together with an accurate map or plat of the territory annexed shall be filed in the office of the Ad Valorem division of the Oklahoma Tax Commission.

Section 8: EMERGENCY CLAUSE: Whereas an emergency exists for the preservation of public peace, health, safety and welfare, by reason whereof this ordinance will take effect immediately upon its passage and approval.
