ANNEXATION OF LAND INTO OAKS WARD 1

6/19

BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE CITY OF OAKS, OKLAHOMA, THAT, TO WIT:

SECTION 1: THE FOLLOWING DESCRIBED PROPERTY IS HEREBY ANNEXED INTO THE TOWN OF OAKS, OKLAHOMA, WARD 1 WITH LEGAL DESCRIPTION OF:

TRACT 1: A TRACT OF LAND CONTAINED WITHIN PART OF THE W1/2 OF SW1/4, SECTION 27, TOWNSHIP 20 NORTH, RANGE 23 EAST, BEGINNING 1111.29 FEET NORTH OF THE SW CORNER OF THE SW, THENCE NORTH 344.71 FEET, THENCE EAST 324 FEET, THENCE SOUTH 136 FEET, THENCE WEST 115.29 FEET, THENCE SOUTH 208.71 FEET, THENCE West 208.71 FEET TO THE POINT OF BEGINNING.


