



ORDINANCE NO 1-202.1.2

ANNEXATION OF LAND INTO OAKS WARD 1

BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE CITY OF OAKS, OKLAHOMA, THAT, TO WIT:

SECTION 1: THE FOLLOWING DESCRIBED PROPERTY IS HEREBY ANNEXED INTO THE TOWN OF OAKS, OKLAHOMA, WARD 1 WITH LEGAL DESCRIPTION OF:

TRACT 1: A TRACT OF LAND CONTAINED WITHIN PART OF THE W1/2 OF SW1/4, SECTION 27, TOWNSHIP 20 NORTH, RANGE 23 EAST, BEGINNING IN THE SW CORNER OF SW 1/4, SW 1/4, SW 1/4 , THENCE NORTH 208.71 FT. THENCE EAST 208.71 FT. THENCE SOUTH 208.71 FT, THENCE WEST 208.71 FT. TO THE POINT OF BEGINNING, CONTAINING 1 ACRE, MORE OR LESS, DELAWARE COUNTY, OKLAHOMA AND A TRACT OF LAND THAT IS THE EAST 121.54 FT. OF THE SOUTH 208.71 FT. OF THE SW 1/4 OF THE SW 1/4 OF SECTION 27, TOWNSHIP 20 NORTH RANGE 23 EAST OF THE INDIAN BASE AND MERIDIAN, DELAWARE COUNTY, OKLAHOMA.

SECTION 2: THAT ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH BE AND THE SAME ARE HEREBY EXPRESSLY REPEALED.




