

AN ORDINANCE OF THE TOWN OF OCHELATA, OKLAHOMA, A MUNICIPAL CORPORATION, EXTENDING THE CORPORATE LIMITS OF THE TOWN OF OCHELATA, WASHINGTON COUNTY, STATE OF OKLAHOMA, TO INCLUDE THE FOLLOWING REAL PROPERTY SITUATED IN WASHINGTON COUNTY, STATE OF OKLAHOMA, MORE PARTICULARLY DESCRIBED AS FOLLOWS, TO-WIT:

Beginning at the SE Corner of the SE/4 SW/4 SE/4; thence West 450'; thence North 384.7'; thence West 210'; thence North 175.3'; thence East 137.5'; thence North 100'; thence East 522.5'; thence South 660' to the point of beginning in Section 36, Township 25 North, Range 12 East;

and

The North 174.7' of the South 384.7' of the West 210' of the SE/4 SW/4 SE/.4, Section 36, Township 25 North, Range 12 East;

and

Lots 1, 2, 3 and 4, Block 1, Hendricks 2nd; Addition, Washington County, State of Oklahoma.

WHEREAS, the Board of Trustees of the Town of Ochelata believes it in the best interest of the Town and the public to annex the above-described real property into the corporate limits of the Town of Ochelata.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Town of Ochelata, Oklahoma, meeting in special session at Town Hall, Ochelata, Washington County, Oklahoma, on this 30th day of November, 2010, as follows, to-wit:

Section One (1): Annexation of Territory.

There is hereby annexed to the Town of Ochelata, Washington County, Oklahoma, and incorporated within the corporate boundaries thereof, the following territory adjoining the present corporate boundaries of the Town of Ochelata, to-wit:

Beginning at the SE Corner of the SE/4 SW/4 SE/4; thence West 450'; thence North 384.7'; thence West 210'; thence North 175.3'; thence East 137.5'; thence North 100'; thence East 522.5'; thence South 660' to the point of beginning in Section 36, Township 25 North, Range 12 East;

and

The North 174.7' of the South 384.7' of the West 210' of the SE/4 SW/4 SE/.4, Section 36, Township 25 North, Range 12 East;




