**AN ORDINANCE FOR THE TOWN OF OKARCHE, OKLAHOMA, ANNEXING THE LAND DESCRIBED IN EXHIBIT A, ATTACHED HERETO, ADJACENT OR CONTIGUOUS TO THE TOWN OF OKARCHE, OKLAHOMA; DECLARING SEVERABILITY; DECLARING REPEALER; AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED BY THE BOARD OF TRUSTEES FOR THE TOWN OF OKARCHE, OKLAHOMA:**

Section 1. The Board of Trustees has determined that the land on the attached Exhibit A is adjacent or contiguous to the Town of Okarche and that notice of the proposed annexation was given pursuant to Title 11 O.S. Section 21-104 and that a public hearing was conducted pursuant to that statute and, therefore, all of the territory described in the attached Exhibit A are annexed into the limits of the Town of Okarche pursuant to said statute.

Section 2. Severability.

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, said portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions of this Ordinance.

Section 3. Repealer.

All former ordinances or parts of Ordinances conflicting or inconsistent with the provisions of this Ordinance are hereby repealed.

Section 4. Emergency.

It being immediately necessary for the preservation of the public health, peace and safety of the Town of Okarche and the inhabitants thereof, an emergency is hereby declared to exist by reason whereof, this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.

PASSED AND APPROVED and the Emergency Clause voted upon separately and passed and approved this 5th day of April, 2006.


THAT PORTION OF THE NW 1/4 OF SECTION 32 WEST OF THE RAILROAD

OKLAHOMA.




