

AN ORDINANCE AMENDING AND CORRECTING THE LEGAL DESCRIPTIONS OF ORDINANCE 2004-04 EXTENDING THE CORPORATE LIMITS OF THE TOWN OF OOLOGAH AND DESIGNATING THE AREAS OR TRACTS INCLUDED IN SUCH EXTENSION; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH, PROVIDING THAT IF ANY PART OR PARTS HEREOF BE HELD INVALID OR INEFFECTIVE, THE REMAINING PORTIONS SHALL NOT BE AFFECTED; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE TOWN OF OOLOGAH, OKLAHOMA, AS FOLLOWS:

Section 1. That the Town of Oologah, State of Oklahoma, desires to annex certain property to the corporate limits of the Town.

Section 2. That the property to be annexed is contiguous and adjacent to the present limits of the Town, and is not presently incorporated within the Limits of the Town, and Petitions have been received from the owners of that property requesting that the property be annexed into the Town of Oologah. That pursuant to the laws made and provided for by the State of Oklahoma, including 11 O.S. § 21-105, the property hereinafter described may be lawfully annexed to the Town, henceforth, be considered for all purposes part of the Town.

That the following described real property and premises, situated in Rogers County, Oklahoma, being the same is hereby annexed to the Town of Oologah, State of Oklahoma, to-wit:

The SE $\frac{1}{4}$ SE $\frac{1}{4}$ less the South 1.04 acres for Highway, all in Section 27, Township 23 North, Range 15 East.

and

The E $\frac{1}{2}$ E $\frac{1}{2}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 27, Township 23 North, Range 15 East.

and

The W $\frac{1}{2}$ E $\frac{1}{2}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 27, Township 23 North, Range 15 East.

and

The E $\frac{1}{2}$ W $\frac{1}{2}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 27, Township 23 North, Range 15 East.

That there shall be filed in the Office of the County Clerk of Rogers County, State of Oklahoma, a true and certified copy of the Ordinance together with an accurate map of the territory hereby annexed.

For the preservation of the public peace, health, welfare and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall become effective immediately upon its passage, approval and publication as required by law.

PASSED and the emergency clause voted upon separately, and approved in regular session this 20 day of Sept, 2004.
