

ORDINANCE 1038

AN ORDINANCE ANNEXING TO THE CITY OF PAWNEE, OKLAHOMA, THE FOLLOWING DESCRIBED LAND, TO-WIT:

A tract of land containing ten (10) acres, more or less, the same being part of the South Half (S/2) of the Southeast Quarter (SE/4) of Section Twenty-nine (29), Township Twenty-two (22) North, Range Five (5) East of the Indian Meridian, in Pawnee County, State of Oklahoma, and described by metes and bounds as follows: Commencing at a point 1,295 feet North and 1,650 feet West of the Southeast Corner of the said Southeast Quarter (SE 1/4) of Section Twenty-nine (29); Thence due West a distance of 660 feet; Thence South 635 feet, Thence East 660 feet; Thence North 635 feet to the place of beginning.

Whereas the owner of the territory described herein, which is adjacent to the city limits of Pawnee, Oklahoma has filed with the city council of the City of Pawnee, Oklahoma its petition for annexation of said property within the city limits of said city;

Whereas, said property is not now embraced within the limits of said city and the city council deems that it is proper and to the benefit of said city if such territory is annexed to the corporate limits thereof;

Now therefore be it ordained by the Mayor and Council of the City of Pawnee, Oklahoma,

Section 1.

That the following described real property in Pawnee, Oklahoma, to wit:



Be and the same is hereby annexed to and made a part of the city of Pawnee, Oklahoma.




An accurate map of the territory added to the corporate limits of the City of Pawnee, Oklahoma by this ordinance is attached hereto and made a part hereof by reference.




