

ORDINANCE NO. 319



"AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF PERKINS, OKLAHOMA, TO INCLUDE CERTAIN PROPERTY, MORE PARTICULARLY HEREINAFTER DESCRIBED, IN THE SOUTHEAST QUARTER OF SECTION 6, TOWNSHIP 17 NORTH, RANGE 3 EAST OF THE I.M., PAYNE COUNTY, OKLAHOMA, AS PROVIDED BY LAW, AND DECLARING AN EMERGENCY."

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF PERKINS, STATE OF OKLAHOMA:

SECTION 1: That the corporate limits of the City of Perkins, Oklahoma, be and the same are hereby extended to include the following described properties, situated in Payne County, State of Oklahoma, to-wit:

A tract of land in the Southeast Quarter (SE/4) of Section Six (6), Township 17 North, Range Three (3) East of the Indian Meridian, Payne County, Oklahoma, being more particularly described as follows:  
Commencing at the Northeast Corner (NE/C) of the Southeast Quarter (SE/4) of Said Section 6; thence South 06°24'29" East along the Section Line a distance of 1696.99 feet; thence South 89°21'15" West a distance of 1558.29 feet to the Point of Beginning;  
THENCE continuing South 89°21'15" West a distance of 690.27 feet to a point on the East Line of Timberline Addition;  
THENCE South 03°27'23" East a distance of 950.36 feet to a point on the South Line of the Southeast Quarter (SE/4);  
THENCE North 88°55'10" East along said South Line a distance of 690.03 feet;  
THENCE North 03°27'23" West a distance of 945.12 feet to the Point of Beginning, containing 15.00 acres, more or less.

SECTION 2: The Perkins City Commission finds that the above described property is adjacent to, or abutting on the corporate limits of the City of Perkins, Oklahoma, and that the owners of at least three-fourths (3/4ths) of said property have given consent in writing, and that, therefore, the annexation of said territory is authorized by the Statutes of the State of Oklahoma.

SECTION 3: That the above-described property shall be zoned "residential" as defined by City Ordinance.

SECTION 4: That the City Clerk be and she is hereby authorized and directed to cause a certified copy hereof to be filed and recorded in the office of the County Clerk of Payne County, Oklahoma, as provided by law.

SECTION 5:           Emergency Clause

It being immediately necessary for the preservation of the peace, health and safety, an emergency is hereby declared to exist by reason whereof this ordinance shall take effect and be in full force and in effect from and after its passage, approval and publication.


