

AN ORDINANCE DETACHING A TRACT OF LAND DESCRIBED AS THE NORTHWEST QUARTER OF SECTION 27, TOWNSHIP 14 NORTH, RANGE 6 W.I.M., CANADIAN COUNTY, OKLAHOMA; AND DE-ANNEXING SAID TRACTS FROM THE CITY LIMITS OF THE TOWN OF PIEDMONT, OKLAHOMA; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE MAYOR AND BOARD OF TRUSTESS OF THE TOWN OF PIEDMONT, OKLAHOMA, A MUNICIPAL CORPORATION:

SECTION 1.

WHEREAS, a petition was filed by Emma A. Allison the owner of the Northwest Quarter of Section 27, Township 14 North, Range 6 W.I.M., Canadian County, Oklahoma, to detach from the Town of Piedmont, Oklahoma the said Northwest Quarter of Section 27, Township 14 North, Range 6 W.I.M., Canadian County, Oklahoma.

SECTION 2.

WHEREAS, it appears that said land is not surrounded on three sides, and is separated by land noncontiguous to the Town of Piedmont.

AND WHEREAS, said land is an agricultural land used entirely for the raising of livestock and agricultural purposes.

AND WHEREAS, it would be impossible for the Town of Piedmont to serve said tract with sewer or any other utilities.

AND WHEREAS, said tract is used by the Petitioner for her livelihood.

AND WHEREAS, it appears to redound to the benefit of the Town of Piedmont as well as the Petitioner, that said tract be de-annexed.

SECTION 3.

BE IT THEREFORE ORDAINED, that from and after the approval, passage, and publication of this Ordinance, that said tract of land described as the Northwest Quarter of Section 27, Township 14 North, Range 6 W.I.M., Canadian County, Oklahoma, be in the same is hereby detached and de-annexed from the town limits and from the Town of Piedmont, Oklahoma.

SECTION 4. EMERGENCY

WHEREAS, it appears to be for the best interest, comfort, health, safety, welfare, and protection of the inhabitants of the Town of Piedmont, that this Ordinance be placed in full force and effect immediately, that an emergency should be declared.

IT IS THEREFORE ORDAINED, that an emergency is hereby declared to exist, whereby this Ordinance will be in full force and effect immediately upon the approval, passage and publication thereof.
