AN ORDINANCE DEANNEXING FROM THE CORPORATE LIMITS OF THE TOWN OF PIEDMONT, OKLAHOMA, CERTAIN PROPERTY LOCATED IN SECTION 35, TOWNSHIP 15 NORTH, RANGE 6 WEST, KINGFISHER COUNTY, OKLAHOMA, AS MORE FULLY DESCRIBED HEREIN; PROVIDING FOR SEVERABILITY AND REPEALER; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF PIEDMONT:

Section 1. Whereas, petitions signed by three-fourths (3/4) of the registered voters and by the owners of at least three-fourths (3/4), in value, of the property hereinafter described have been filed with the Town of Piedmont, Oklahoma, requesting that said property be detached or deannexed from the corporate limits of the Town of Piedmont, Oklahoma.

Section 2. Whereas, notice of hearing said petitions has been given by publication once a week for two successive weeks in the Piedmont-Surrey Gazette.

Section 3. The following-described property in Kingfisher County, Oklahoma, is hereby deannexed and detached from the corporate limits of the Town of Piedmont, Oklahoma, to-wit:

The Northeast Quarter (NE/4) of Section 35, Township 15 North, Range Six West, I.M., to Kingfisher County, Oklahoma. Containing 160 acres more or less.

Section 4. The Town Clerk is hereby directed to cause a copy of this Ordinance to be filed in the office of the County Clerk of Kingfisher County, Oklahoma, along with an accurate map of the detached territory.

Section 5. If any part, article, section, or subsection of this Ordinance shall be held invalid or unconstitutional for any reason such holding shall not be construed to impair or invalidate the remainder of this Ordinance, notwithstanding such holding.

Section 6. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 7. It being immediately necessary for the preservation of the public peace, health, safety, and welfare of the Town of Piedmont and the inhabitants thereof that this Ordinance be put into full force and effect, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force


