

ORDINANCE NO. 231

AN ORDINANCE AMENDING THE ZONING ORDINANCES AND MAP OF THE CITY OF PIEDMONT BY INCLUDING IN A-1, AGRICULTURAL ZONING USE DISTRICT THE PROPERTY DESCRIBED AS THE NORTHEAST QUARTER OF SECTION THREE, TOWNSHIP FOURTEEN NORTH, RANGE FIVE WEST, AND THE SOUTH HALF OF SECTION FOUR, TOWNSHIP FOURTEEN NORTH, RANGE FIVE WEST; THE NORTHEAST QUARTER OF SECTION NINE AND THE EAST HALF OF THE SOUTHEAST QUARTER OF SECTION NINE, TOWNSHIP FOURTEEN NORTH, RANGE FIVE WEST; THE EAST HALF OF THE NORTHWEST QUARTER OF SECTION SIXTEEN, TOWNSHIP FOURTEEN NORTH, RANGE FIVE WEST; THE NORTHWEST QUARTER OF SECTION TEN, TOWNSHIP FOURTEEN NORTH, RANGE FIVE WEST; THE SOUTH HALF OF SECTION TEN AND THE EAST HALF OF SECTION FIFTEEN, AND THE NORTHWEST QUARTER OF SECTION FIFTEEN, TOWNSHIP FOURTEEN NORTH, RANGE FIVE WEST, CANADIAN COUNTY, OKLAHOMA, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PIEDMONT:

Section 1. The following described real estate situated in the City of Piedmont, Canadian County, State of Oklahoma, to-wit:

The NE/4 of Section 3, T14N, R5W, and the S/2 of Section 4, T14N, R5W; the NE/4 of Section 9 and the E/2 of the SE/4 of Section 9, T14N, R5W; the E/2 of the NE/4 of Section 16, T14N, R5W; the NW/4 of Section 10, T14N, R5W; the S/2 of Section 10 and the E/2 of Section 15, and the NW/4 of Section 15, T14N, R5W, Piedmont, Canadian County, Oklahoma;

is hereby included in, added to, and made a part of the district set aside for A-1, Agricultural use, and the Clerk of the City of Piedmont is hereby authorized and directed to correct the official zoning map of the City of Piedmont to conform thereto.

Section 2. It being immediately necessary for the preservation of the public peace, health, safety, and welfare of the City of Piedmont and the inhabitants thereof that this Ordinance be put into full force and effect, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force and effect from and after its passage and approval.
