Ordinance No. 71

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN REAL ESTATE TO THE TOWN OF PIEDMONT, STATE OF OKLAHOMA

Be it ordained by the Board of Trustees of the Town of Piedmont as follows:

That pursuant to petitions which are a part of the records of the Board of Trustees of persons representing not less than three-fourths (3/4ths) of the legal voters and not less than three-fourths (3/4ths) in value of the property therein described have been duly filed with the Board of Trustees and approved in every respect by said Board, and that an accurate map of the territory annexed duly certified by the Chairman of the Board of Trustees has been furnished, that by virtue of 11 Okl. St. Ann. Section 482, the following properties situated in Canadian County, State of Oklahoma, all lying in Township 14 North, Range 5 West of the Indian Meridian are hereby annexed to the town of Piedmont:

The East Half (E/2) of the Northeast Quarter (NE/4) of the Northwest Quarter (NW/4) of the Northwest Quarter (NW/4) and the Southeast Quarter (SE/4) of the Northwest Quarter (NW/4) of the Northwest Quarter (NW/4) and the South Half (S/2) of the West Half (W/2) of the Northwest Quarter (NW/4) of Section 27; East Half (E/2) of the Northeast Quarter (NE/4) of Section 22; North Half (N/2) of Section 28; East Half (E/2) of the Northeast Quarter (NE/4) of Section 29; North Half (N/2) of Southeast Quarter (SE/4) of Section 29; West Half (W/2) of Section 21; South Half (S/2) of Section 16; Southwest Quarter (SW/4) of Section 15, all in Township 14 North, Range 5 West of the Indian Meridian, Canadian County, State of Oklahoma.

That this Ordinance shall be in full force and take effect from and after its passage, approval and publication as required by law.


