

ORDINANCE NO. 6030

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF PONCA CITY, AND DESIGNATING THE AREAS OR TRACTS INCLUDED IN SUCH EXTENSION, REPEALING ALL ORDINANCES IN CONFLICT OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the Board of Commissioners finds the area described below is adjacent and contiguous to the present corporate limits of the City of Ponca City, and the Board of Commissioners further finds that all of the owners of the described property have consented for said area to be annexed to the City of Ponca City, and the Board of Commissioners further finds that notice, as required by law has been duly given.

WHEREAS, after public hearing before the Ponca City Planning Commission it has been recommended to the Board of City Commissioners of the City of Ponca City that the described land be annexed into the corporate limits of the city;

THEREFORE, BE IT ORDAINED by the Board of City Commissioners of the City of Ponca City, Kay County, State of Oklahoma:

Section 1. That the corporate limits of the City of Ponca City, Oklahoma, be and the same are hereby extended to include the following described tract of land:

A tract of land located in the Southwest Quarter (SW/4) of Section 26, Township 26 North (T26N), Range 2 East (R2E), Indian Meridian (I.M.) Kay County, State of Oklahoma, more particularly described as follows:


Beginning at the Southwest corner of said Southwest Quarter; thence N00°12'33" E along the West line of said Southwest Quarter a distance of 600.00 feet; thence S89°08'04"E and parallel to the South line of said Southwest Quarter a distance of 600.00 feet; thence S00°12'33"W and Parallel to the West line of said Southwest Quarter a distance of 600.00 feet to a point on the South line of said Southwest Quarter, thence N89°08'04"W along the South line of said Southwest Quarter; a distance of 600.00 feet to the Point of Beginning. Said tract containing 8.26 acres more or less. Subject to all Easements and Rights of Way of record.

Section 2. The above described property is hereby zoned C-2 General Commercial


Section 3. All ordinances or parts of ordinance in conflict herewith are hereby repealed.

Section 4. This ordinance shall be in full force and effect from and after its publication.


