An ordinance annexing RIGHTS of Way in Wagoner County, State of Oklahoma, into the City limits of the City of Porter, Oklahoma, granting a zoning classification, adopting a service plan and declaring an emergency

BE IT ORDAINED BY THE MAYOR AND TOWN TRUSTEES OF THE CITY OF PORTER:

SECTION I: That the following described tracts of land lying adjacent to the present corporate City limits of Porter Oklahoma to-wit:


The West 24.75 feet of Sections 9 and 4 T16N R17E,  
The North 24.75 feet of Sections 1, 2 and 3 T16N R17E,  
The North 24.75 feet of Sections 4, 5 and 6 T16N R18E,  
The East 24.75 feet of Sections 4, 9, 16, 21, and 33 T16N R18E,  
The South 24.75 feet of Sections 31, 32 and 33 of T16N R18E,  
The South 24.75 feet of Sections 32, 33, 34, 35 and 36 T16N R17E,  
The East 24.75 feet of and the South 24.75 feet of Section 6 T15N R17E,  
The South 24.75 feet of Section 1 T15N R16E,  
The East 24.75 feet of Section 11 T15N R16E,  
The South 24.75 feet of Sections 9, 10 and 11 T15N R16E,  
The West 24.75 feet of Sections 4 and 9 T15N R16E,  
The West 24.75 feet of Sections 4, 9, 16, 21, 28 and 33 of T16N R16E,  
The North 24.75 feet of Sections 1, 2, 3, and 4 T16N R16E,  
The North 24.75 feet of Sections 4, 5 and 6 T16N R17E,  
All of the Indian Base and Meridian, Wagoner County, State of Oklahoma

Be and the same are hereby annexed to the City of Porter, Oklahoma and the corporate city limits of said city are hereby extended to include the above described tracts of land. After the effective date of this ordinance, all property located therein and all persons residing or otherwise occupying the land shall be subject to the jurisdiction of this City and all laws made pursuant thereto.

SECTION II: An emergency exist for the preservation of the public health, peace and safety and therefore this ordinance shall become effective from and after the time of its passage and approval
