AN ORDINANCE PROVIDING FOR ANNEXATION OF REAL PROPERTY TO THE CITY OF PRAGUE, OKLAHOMA AS SET FORTH BELOW.

BE IT ORDAINED BY THE CITY COUNCIL OF PRAGUE, OKLAHOMA;

SECTION I: The owners of a majority of the whole number of acres owned by residents of the tracts and property, premises, lands and territory hereinafter described having made and executed a consent in writing that the said tracts, property, premises, lands and territory shall be added and annexed to the city limits of the City of Prague, Oklahoma, the same being situated in Lincoln County, Oklahoma, and adjacent to or adjoining the city limits of said City, and being more particularly described as follows:

A TRACT OF LAND IN THE WEST HALF OF THE NORTHWEST QUARTER (W/2 NW/4) OF SECTION THIRTY-THREE (33), TOWNSHIP TWELVE (12) NORTH, RANGE SIX (6) EAST OF THE INDIAN MERIDIAN, BEING DESCRIBED AS:

BEGINNING AT THE NORTHWEST CORNER OF SAID W/2, NW/4 OF SECTION 33, T 12 N, R 6 E, I.M., THENCE EAST ALONG THE SECTION LINE A DISTANCE OF 1320.0' TO THE NORTHEAST CORNER OF SAID W/2 NW/4; THENCE SOUTH ALONG SAID EAST LINE A DISTANCE OF 452.0', THENCE WEST A DISTANCE OF 1320' TO A POINT ON THE WEST LINE OF SAID W/2 NW/4; THENCE NORTH ALONG SAID WEST LINE A DISTANCE OF 452.0' TO THE POINT OF BEGINNING.

A TRACT OF LAND IN THE WEST HALF OF THE SOUTHWEST QUARTER (W/2 SW/4) OF SECTION TWENTY-EIGHT (28), TOWNSHIP (12) NORTH, RANGE SIX (6) EAST OF THE INDIAN MERIDIAN, BEING DESCRIBED AS:

BEGINNING AT THE SOUTHWEST CORNER OF SAID W/2, SW/4 OF SECTION 28, T 12 N, R 6 E, I.M., THENCE NORTH ALONG THE SECTION LINE A DISTANCE OF 1560.33'; THENCE S 67*06' E A DISTANCE OF 811.2'; THENCE NORTH A DISTANCE OF 160.0'; THENCE S 74*48' E A DISTANCE OF 585.3' TO A POINT ON THE EAST LINE OF SAID W/2 SW/4; THENCE SOUTH ALONG SAID EAST LINE A DISTANCE OF 1295.3' TO A POINT ON THE SOUTH LINE OF SAID W/2, SW/4; THENCE WEST ALONG SAID SOUTH LINE A DISTANCE OF 1320.0' TO THE POINT OF BEGINNING.

And the annexation of each, every and all of the above described property premises, lands and territory being essential to the continued growth and progress of said City, and to the advantage of the residents thereof, said property, premises, lands, and each and every



part, parcel and portion thereof be and the same is hereby declared fully annexed and added to the incorporated limits of and made a part of the City of Prague, Oklahoma, pursuant to the provisions of law applicable thereto.


SECTION II - EMERGENCY CLAUSE:
