ORDINANCE NO. 02-07

AN ORDINANCE EXTENDING THE CITY LIMITS OF THE CITY OF PURCELL, OKLAHOMA, TO INCLUDE LANDS LOCATED IN SECTION 24, T6N, R2W; EFFECTIVE UPON PASSAGE AND PUBLICATION; AND TO CHANGE THE NAME OF THE STREET IN THE PROPERTY TO BE ANNEXED FROM BLANTON VIEW AVENUE TO SOUTH 9TH STREET, EFFECTIVE UPON PASSAGE AND PUBLICATION.

WHEREAS, the City Council of the City of Purcell, Oklahoma, in planning for the future growth and development of said City has determined that it is in the best interest of the City of Purcell and its citizens to annex the real property specifically described in the ordinance; and

WHEREAS, the City Council of the City of Purcell, Oklahoma, has determined the street located in the property to be annexed now named Blanton View Avenue, shall be re-named South 9th Street;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PURCELL:


Section 1. The City limits of the City of Purcell, Oklahoma be extended to include the following described property, to-wit:

Beginning at the SW corner of said SW 1/4 SW 1/4 of said Section 24, T6N, R2W, thence North along the West line of said SW 1/4 SW 1/4 and the S 1/2 NW 1/4 SW 1/4 a distance of 1,467.93 feet, thence N 89° 29' 55" E a distance of 33.00 feet, thence S 9° 49' 53" E a distance of 259.52 feet, thence S 7° 23' 45" E a distance of 1,221.42 feet to a point on the South line of said SW 1/4 SW 1/4, thence West along said South line a distance of 221.69 feet to point of beginning.


ALSO: W 16.5 feet of Section 24, T6N R2W.
And the same is hereby annexed to said City.

Section 2. The street currently known as Blanton View Avenue, shall be re-named South 9th Street, and be provided with City of Purcell addresses.
