

AN ORDINANCE OF THE CITY OF PURCELL, OKLAHOMA, EXTENDING THE CITY LIMITS OF THE CITY OF PURCELL, OKLAHOMA, TO INCLUDE LANDS LOCATED IN PART OF SECTION 35 TOWNSHIP 7 NORTH, RANGE 2 WEST, ALL IN MCCLAIN COUNTY, STATE OF OKLAHOMA, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

EXHIBIT A

A TRACT OF LAND IN THE NW/4 SW/4 NW/4 OF SECTION 35, T7N, R2W, MCCLAIN COUNTY, STATE OF OKLAHOMA, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT A POINT 66 FEET NORTH OF THE SOUTHWEST CORNER OF THE SAID NW/4 SW/4 NW/4 GOING THENCE NORTH 132 FEET ALONG THE WEST LINE OF SAID SECTION 35, THENCE EAST 660 FEET; THENCE SOUTH 132 FEET, THENCE WEST 660 FEET TO THE POINT OF BEGINNING.

EXHIBIT B

A PART OF THE NORTHWEST QUARTER (NW/4) OF NORTHWEST QUARTER (NW/4) OF SECTION THIRTY-FIVE (35), TOWNSHIP SEVEN (7) NORTH, RANGE TWO (2) WEST, MCCLAIN COUNTY, OKLAHOMA, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE NE/CORNER OF SAID NW/4 NW/4 NW/4 AND GOING THENCE SOUTH 330 FEET; THENCE WEST 660 FEET; THENCE NORTH 330 FEET; THENCE EAST 660 FEET TO THE POINT OF BEGINNING.

A TRACT OF LAND BEING LOCATED IN THE SW/4, OF SECTION 26, T7N, R2W, OF THE INDIAN MERIDIAN, MCCLAIN COUNTY, OKLAHOMA, MORE PARTICULARLY DESCRIBED AS FOLLOWS; BEGINNING AT A POINT 700.2 FEET EAST OF THE SW CORNER OF THE SAID SW/4;

 THENCE N53°26"E FOR A DISTANCE OF 715.53 FEET;
 THENCE S26°00"E FOR A DISTANCE OF 220.61 FEET;
 THENCE S00°00"W FOR A DISTANCE OF 673.0 FEET;
 THENCE N90°00"W FOR A DISTANCE OF 671.4 FEET;

TO THE POINT OR PLACE OF BEGINNING CONTAINING 10.40 ACRES, MORE OR LESS.

TO BE EFFECTIVE IMMEDIATELY UPON PASSAGE AND PUBLICATIONS AND DECLARING AN EMERGENCY.
