

ORDINANCE NO. 30

AN ORDINANCE AMENDING THE CORPORATE BOUNDARIES OF THE TOWN OF ROSSTON, OKLAHOMA, BY DETACHING AND DE-ANNEXING LANDS, AND DESIGNATING THE AREAS OR TRACTS INCLUDED IN THE AMENDMENT AND DETACHMENT, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF ROSSTON, OKLAHOMA:

SECTION 1: WHEREAS the following described real estate is situated in Harper County, State of Oklahoma. The corporate limits of the Town of Rosston, Oklahoma, be and the same are hereby amended to detach the following described real property in Harper County, State of Oklahoma pursuant to authority granted by Title 11 O.S., Section 21-110, to wit:

Tracts Four (4), Five (5), Six (6), and Seven (7) in Ross' Third Addition to the Town of Ross, Oklahoma, according to the recorded plat thereof. Said Ross' Third Addition is situated in the East Half of the Southwest Quarter (E/2 SW/4) of Section Eighteen (18), Township Twenty-seven (27) North, Range Twenty-five (25) W.I.M.

SECTION 2: Now therefore be it ordained by the Board of Trustees of the Town of Rosston, Oklahoma, that the above described Tract of land be and the same is hereby detached from the corporate limits of the Town of Rosston, Oklahoma, and the boundaries of said Town of Rosston, Oklahoma, will be redrawn to exclude said Tract of land, and said Tract of land is removed from the jurisdiction of the Town of Rosston, Oklahoma, without further liability by the owners thereof.


