

ORDINANCE NO. 1983-2

AN ORDINANCE OF THE TOWN OF RYAN, OKLAHOMA, PROVIDING FOR THE ANNEXATION OF ADDITIONAL TERRITORY HEREINAFTER DESCRIBED TO THE CORPORATE LIMITS OF THE TOWN OF RYAN, OKLAHOMA; AND DECLARING AN EMERGENCY.

WHEREAS, it has been determined by the Board of Trustees of the Town of Ryan, Oklahoma, that more than two weeks prior to this date, a petition, in writing, signed by the legal owners of the hereinafter described real estate, was presented to said Town Board requesting annexation of said hereinafter described property, and that notice of the presentation of said petition has been given by publication in the January 20, and January 27, 1983, issues of the Ryan Leader, which newspaper is published in the Town of Ryan, Oklahoma, all as required by the Laws of the State of Oklahoma; and

WHEREAS, an accurate map of said territory proposed to be annexed by said petition has been presented to the Board of Trustees of the Town of Ryan, Oklahoma; and

WHEREAS, it has been determined by the Town Board of Trustees that all of the necessary steps have been taken and all of the relevant Statutes of the State of Oklahoma and the Ordinances of the Town of Ryan, Oklahoma, pertaining to such annexation procedures have been complied with in their entirety.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF RYAN, OKLAHOMA:

SECTION 1. Certain Land Annexed to City.

The following described territory (comprising 39.0 acres, more or less) is hereby annexed to the Town of Ryan, Oklahoma:

The SE/4 of the NE/4 of Section 19, Township 6 South, Range 7 West, I.M., Jefferson County, Oklahoma, less and except the South 208.71 feet of the West 208.71 feet thereof.

SECTION 2. Emergency.

It being immediately necessary for the preservation of the public health, peace and safety of the people of the Town of Ryan, Oklahoma, an emergency is hereby declared to exist whereby this Ordinance shall be effective immediately upon its passage, approval and publication, as required by Law.





R 7 W S89° 39'E




ANNEXATION OF THE SE-1/4 OF NE-1/4
