ORDINANCE NO. 2003- 3

An Ordinance annexing certain lands legally described adjacent to the Town of Salina, Mayes County, Oklahoma, pursuant to 11 O.S.A. §21-104. Said ordinance specifically includes a Municipal Service Extension Plan attached hereto and made a part of this ordinance by reference; extending the corporate limits of the Town of Salina, Oklahoma, making findings of fact; annexing an area legally adjacent to the Town of Salina into the corporate limits of said township, as annexation is more particularly described and declaring an emergency.

This annexation specifically incorporates into the corporate limits of the Town of Salina, the E/2 W/2 SE/4 SW/4 and E/2 SE/4 SW/4 in Section 14, Township 21 North, Range 20 East containing 30 acres more or less and certain portion of Section 14, Township 21 North, Range 20 East, beginning at the SW corner of SW/4 SE/4 then Running North 416 feet, East 165 feet, South 160 feet, East 240 feet to road to the South line of section then West 310 feet to the point of beginning, all in Mayes County, State of Oklahoma.

WHEREAS, a proper hearing having been held before the Board of Trustees of the Town of Salina to consider said annexation, and whereas, on the 9th day of September, 2003 a notice of annexation proposal was adopted by the Board of Trustees of the Town of Afton, and whereas, following same that Notice was given as provided for in 11 O.S.A. §21-104 by first class mail to all land owners within the area being considered for annexation, in accordance with the current roll of the office of the County Treasurer of Mayes, and whereas publication concerning same was properly had in a newspaper of general circulation within Mayes County, Oklahoma, and whereas Notice has been properly given of the adoption of the Service Extension Plan as required by law and whereas the 14th day of October, 2003 at 7:00 p.m. it was set for a review of the Service Extension Plan and for Annexation of the territory in question and whereas no objection to the Service Extension Plan being proposed, and likewise no changes in said Service Extension Plan being made, that the Board of Trustees of the Town of Salina do take the following action:

THE BOARD BY PROPER VOTE DOES HEREBY ORDER AND DECREE THAT THE ABOVE HEREIN DESCRIBED PROPERTY, IMMEDIATELY ADJACENT TO THE TOWN OF SALINA BE BY THE ACTION OF THIS ORDINANCE ANNEXED INTO THE CORPORATE LIMITES OF THE TOWN OF SALINA, DONE AS THE LAWFUL AND LEGAL ACT WITH THE BOARD OF TRUSTEES OF THE TOWN OF SALINA AND THAT THE BOUNDARIES AND BORDERS AND LEGAL LIMITS OF THE TOWN OF SALINA, MAYES COUNTY, OKLAHOMA ARE EXTENDED AND ENLARGED SO AS TO INCLUDE ALL OF


