ORDINANCE NO. 1051

AN ORDINANCE ANNEXING A CERTAIN TRACT OF LAND LOCATED IN SECTION 30, TOWNSHIP 19 NORTH, RANGE 12 EAST, TULSA COUNTY, OKLAHOMA, IN SAND SPRINGS WARD BOUNDARY DISTRICT NUMBER 4, AND MORE PARTICULARLY DESCRIBED HEREINAFTER, WITHIN THE MUNICIPAL LIMITS OF THE CITY OF SAND SPRINGS, REPEALING ALL ORDINANCES OR PARTS THEREOF IN CONFLICT HEREWITH, AND DECLARING AN EMERGENCY.

WHEREAS, it is deemed desirable by the City Council of Sand Springs that the tract of land, more particularly described hereinafter, be annexed into the Municipal limits of the City of Sand Springs, Oklahoma, and

WHEREAS, all things necessary and proper for the annexation within the Municipal Limits of the City of Sand Springs and the inclusion therein of the tract of land, more particularly hereinafter described, having been done and performed, and

WHEREAS, it is deemed desirable and beneficial for the citizens of the City of Sand Springs, Oklahoma, that the tract of land hereinafter described be annexed into the Municipal Limits,

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SAND SPRINGS, OKLAHOMA,

SECTION 1: That the following described real estate generally located on the south side of West 41st Street, east of SH97, and further described to wit:

A tract, piece or parcel of land lying in Government Lot 1 of the Northwest Quarter of Section 30, Township 19 North, Range 12 East, Indian Meridian, Tulsa County, Oklahoma, more particularly described as follows:

Commencing at the Northwest Corner of said Government Lot 1; Thence East along the North line of said Government Lot 1 a distance of 1351.68 feet; Thence South along the East line of said Government Lot 1 a distance of 325.50 feet to a point and place of beginning; Thence South along the East line of said Government Lot 1 a distance of 330 feet; Thence West and parallel to the North line of said Government Lot 1 a distance of 330 feet; Thence North and parallel to the East line of said Government Lot 1 a distance of 330 feet; Thence East and parallel to the North line of said Government Lot 1 a distance of 330 feet to the point and place of beginning, described tract containing 2.5 acres more or less, and generally located south of 41st Street (east of South SH97), abutting the National Guard Armory & Reserve, as generally depicted on the accompanying map,

be here and the same annexed to and declared to be hereafter included within the Corporate Limits of the City of Sand Springs, Oklahoma.

SECTION 2: That from and after the effective date of this Ordinance, the property hereinabove described shall be a part of the City of Sand Springs, Oklahoma, and all persons residing thereon and all property situated thereon shall be, and are hereby declared to be, subject to the jurisdiction, control, laws and Ordinances of the City of Sand Springs, Oklahoma, in all respects and particulars.

SECTION 3: WHEREAS, in the judgment of the City Council of the City of Sand Springs, Oklahoma, the public peace, health and safety of the City of Sand Springs, and the inhabitants thereof, demand the immediate passage of this Ordinance, an emergency is hereby declared, the rules are suspended and this Ordinance shall be full force and effect upon its approval and publication as provided by law.




