AN ORDINANCE ANNEXING CERTAIN TRACTS OF RIGHT-OF-WAY, A PORTION OF US412 SERVICE ROAD KNOWN AS WEKIWA ROAD LOCATED IN SECTIONS 10 AND 11 TOWNSHIP 19 NORTH, RANGE 11 EAST, TULSA COUNTY, OKLAHOMA, IN SAND SPRINGS WARD BOUNDARY DISTRICT NUMBER 2, AND MORE PARTICULARLY DESCRIBED HEREINAFTER, WITHIN THE MUNICIPAL LIMITS OF THE CITY OF SAND SPRINGS, REPEALING ALL ORDINANCES OR PARTS THEREOF IN CONFLICT HEREWITH, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is deemed desirable by the City Council of Sand Springs that the tracts of right-of-way land, a segment of US-412 Service Road known as Wekiwa Road that is within a portion of Section 11 and across all of Section 10, more particularly described hereinafter, be annexed into the Municipal limits of the City of Sand Springs, Oklahoma, and

WHEREAS, all things necessary and proper for the annexation within the Municipal Limits of the City of Sand Springs and the inclusion therein of Wekiwa Road, more particularly hereinafter described, having been done and performed, and

WHEREAS, it is deemed desirable and beneficial for the citizens of the City of Sand Springs, Oklahoma, that the right-of-way hereinafter described be annexed into the Municipal Limits,

THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SAND SPRINGS, OKLAHOMA,

SECTION 1: That the following described right-of-way, further described to wit:

A tract of land located in Sections 10 and 11, T-19-N, R-11-E, I.B.&M., Tulsa County, Oklahoma, being more particularly described as follows:

Beginning in Sec. 11, T-19-N, R-11-E, I.B.&M. at the intersection of the centerline of Wilson Avenue being in the City of Sand Springs and the northerly right-of-way of US Highway 412; thence westerly along the northerly right-of-way of US Highway 412 an approximate distance of 0.2 miles to the east line of Sec 10, T-19-N, R-11-E, I.B.&M.; thence westerly along the northerly right-of-way of US Highway 412 an approximate distance of 1.0 miles to the west line of said Sec.10; thence south along the west line of said Sec.10 an approximate distance of 0.1 miles to the southerly right-of-way of US Highway 412; thence easterly along the southerly right-of-way of US Highway 412 an approximate distance of 1.0 miles to the west line of said Sec.11; thence easterly along the southerly right-of-way of US Highway 412 an approximate distance of 0.2 miles to the intersection of the centerline of Wilson Avenue and the southerly right-of-way of US Highway 412; thence easterly along the southerly right-of-way of US Highway 412 an approximate distance of 0.05 miles; thence north to the northerly right-of-way of US Highway 412 an approximate distance of 0.1 miles; thence westerly along the northerly right-of-way an approximate distance of 0.05 miles to the point of beginning, generally known as the expressway service road located by the Quik Trip on Wilson, as generally depicted on the accompanying map,

be here and the same annexed to and declared to be hereafter included within the Corporate Limits of the City of Sand Springs, Oklahoma;

SECTION 2: That from and after the effective date of this Ordinance, the road hereinabove described shall be a part of the City of Sand Springs, Oklahoma, and all persons thereon and all property situated thereon shall be, and are hereby declared to be, subject to the jurisdiction, control, laws and Ordinances of the City of Sand Springs, Oklahoma, in all respects and particulars.




SECTION 3: This Ordinance shall become effective 30 days after its publication.




