ORDINANCE NUMBER 2508

AN ORDINANCE CHANGING THE CORPORATE LIMITS OF THE CITY OF SAPULPA, OKLAHOMA, BY DE-ANNEXING A CERTAIN CONTIGUOUS TRACT OF LAND IN SECTION 5, T18N R12E, CREEK COUNTY, OKLAHOMA, FROM THE CITY LIMITS OF SAPULPA, OKLAHOMA, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL, CITY OF SAPULPA, OKLAHOMA:

Section 1. That the following described tracts of land lying within and on the edge of the present corporate limits of the City of Sapulpa, Oklahoma: to wit:

The North 150 Feet of the South 326 Feet of:

A tract of land located in the Southwest Quarter (SW/4) of Section Five (5), Township Eighteen (18) North, Range Twelve (12) East of the Indian Base and Meridian, in Creek County, State of Oklahoma, according to the U.S. Government Survey thereof, described as follows:

COMMENCING at the SW corner of the SW/4 of Section 5; thence North 89 degrees 30'31" East along the South line of said SW/4 a distance of 610.00 feet to the True Point of Beginning; Thence North 89 degrees 30'31" East along said South line a distance of 792.44 feet; Thence North 01 degrees 03'27" West a distance of 816.04 feet; Thence South 89 degrees 25'21" West a distance of 435.17 feet to the right-of-way of the TULSA-SAPULPA UNION RAILWAY COMPANY; Thence South 00 degrees 34'39" East along said R/W a distance of 28.58 feet; Thence Southwesterly along said R/W and along a curve to the right having a radius of 289.18 feet a distance of 452.24 feet; Thence South 00 degrees 55'07" East along said R/W a distance of 269.17 feet; Thence South 89 degrees 30'31" West along said R/W a distance of 64.35 feet; thence South 00 degrees 56'58" East a distance of 230.00 feet to the True Point of Beginning, containing 13.3 acres more or less.

be and the same are hereby de-annexed from the City of Sapulpa, Oklahoma, and the corporate limits of said City are hereby altered to exclude the above-described tracts of land. After the effective date of this ordinance, all property located therein, and all persons residing or otherwise occupying the lands shall not be subject to the jurisdiction of this City or the laws made pursuant thereto. All requirements of 11 O.S. Section 21-110 have been fully complied with in advance of the issuance of this ordinance.




