

11 2080 ORDINANCE NUMBER 2628

AN ORDINANCE CHANGING THE CORPORATE LIMITS OF THE CITY OF SAPULPA, OKLAHOMA, BY DE-ANNEXING CERTAIN CONTIGUOUS TRACTS OF LAND IN SECTIONS 29 AND 30, T18N R12E, CREEK COUNTY, OKLAHOMA, FROM THE CITY LIMITS OF SAPULPA, OKLAHOMA, AND DECLARING AN EMERGENCY.

WHEREAS, under 11 O.S. § 21-110, the City of Sapulpa, Oklahoma ("City") may detach from the corporate limits any territory when the governing body so directs by ordinance; and

WHEREAS, the following described territory within the municipal limits of the City, to-wit:

THE WEST 24.75 FEET OF THE SOUTH 660 FEET OF SECTION 29, TOWNSHIP 18 NORTH, RANGE 12 EAST, CREEK COUNTY, OKLAHOMA, and

THE EAST 24.75 FEET OF THE SOUTH 660 FEET OF SECTION 30, TOWNSHIP 18 NORTH, RANGE 12 EAST, CREEK COUNTY, OKLAHOMA, (hereinafter the "Territory"); and

WHEREAS, after due consideration of the facts and being sufficiently advised the premises, the City Council hereby finds detachment of the Territory to be in the public interest and necessary for the welfare of the inhabitants of the City of Sapulpa, Oklahoma.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL, CITY OF SAPULPA, OKLAHOMA:

Section 1. That the following described tracts of land lying within the present corporate limits of the City of Sapulpa, Oklahoma: to wit:

THE WEST 24.75 FEET OF THE SOUTH 660 FEET OF SECTION 29, TOWNSHIP 18 NORTH, RANGE 12 EAST, CREEK COUNTY, OKLAHOMA, and

THE EAST 24.75 FEET OF THE SOUTH 660 FEET OF SECTION 30, TOWNSHIP 18 NORTH, RANGE 12 EAST, CREEK COUNTY, OKLAHOMA,


be and the same are hereby detached and de-annexed from the City of Sapulpa, Oklahoma, and the corporate limits of said City are hereby altered to exclude the above-described tracts of land. After the effective date of this ordinance, all property located therein, and all persons residing or otherwise occupying the lands shall not be subject to the jurisdiction of this City or the laws made pursuant thereto. All requirements of 11 O.S. Section 21-110 have been fully complied with in advance of the issuance of this ordinance.

Section 2. Maps. The territory to be detached from municipal limits following de-annexation of the above-described territory is represented by the map attached as Exhibit "A" which is incorporated herein by reference and made a part hereof.



21st PASSED AND APPROVED and the emergency clause ruled upon separately this day of Feb 2011.








