AN ORDINANCE CHANGING THE CORPORATE LIMITS OF THE CITY OF SAPULPA, OKLAHOMA, BY DE-ANNEXING CERTAIN CONTIGUOUS TRACTS OF LAND IN PORTIONS OF SECTION 25, TOWNSHIP 18 NORTH, RANGE 11 EAST OF THE INDIAN BASE AND MERIDIAN, CREEK COUNTY, OKLAHOMA, FROM THE CITY LIMITS OF SAPULPA, OKLAHOMA, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL, CITY OF SAPULPA, OKLAHOMA:

Section 1. That the following described tracts of land lying within and on the edge of the present corporate limits of the City of Sapulpa, Oklahoma: to wit:


Part of Lots 6, 7, 8 and 9, Block "A", BURNETT'S REFINERY ADDITION to the City of Sauplpa, Creek County, State of Oklahoma, according to the Recorded Plat thereof, described as BEGINNING at the NE/corner of Lot 6; thence South along the East boundary of Block "A" in said Addition, a distance of 100 feet to the SE/corner of Lot 9, in Block "A"; thence West along the South boundary of said Lot 9; a distance of 51.8 feet to the East boundary of the Old U.S. Highway 66 right of way line; thence N20°13'W a distance of 79.9 feet to the South boundary of said Lot 6; thence West along said boundary a distance of 21.3 feet; thence N20°13'W a distance of 27.5 feet; thence East along the North boundary of said Lot 6 a distance of 104.9 feet to the point of beginning,

be and the same are hereby de-annexed from the City of Sapulpa, Oklahoma, and the corporate limits of said City are hereby altered to exclude the above-described tracts of land. After the effective date of this ordinance, all property located therein, and all persons residing or otherwise occupying the lands shall not be subject to the jurisdiction of this City or the laws made pursuant thereto. All requirements of 11 O.S. Section 21-110 have been fully complied with in advance of the issuance of this ordinance.

Section 2. EMERGENCY. Being immediately necessary that the provisions of this ordinance be put into full force and effect for the preservation of the public peace, health and safety of the City of Sapulpa, Oklahoma, an emergency is hereby declared to exist and this ordinance shall be in full force and effect after its passage, approval and publication as required by law.

PASSED AND APPROVED and the emergency clause ruled upon separately this 18th day of June 2012.


