**RESOLUTION REGARDING ANNEXATION OF PROPERTY TO TOWN
OF SAWYER, OKLAHOMA**

October 20, 2003

WHEREAS, the Trustees of the Town of Sawyer, Choctaw County, Oklahoma, did, on May 19, 2003, in public meeting, determine that it is in the best interests of the Town and its residents that the Town increase in size;

WHEREAS, in public meetings on June 16, 2003, and September 15, 2003, said Town Trustees did approve that action be taken to annex certain real property which is adjacent to the present municipal limits of the Town of Sawyer, Choctaw County, Oklahoma;

WHEREAS, in public meeting, on June 16, 2003, said Town Trustees, in compliance with the Laws of the State of Oklahoma, did approve a Service Plan to be applied to the proposed annexed territory;

WHEREAS, notice of the proposed annexation has been duly given via certified mail to all owners of property to be annexed as shown by the current year's ownership rolls in the office of the County Treasurer;

WHEREAS, notice of the proposed annexation has been duly published in the Hugo Daily News, a newspaper of general circulation within Choctaw County, as required by State law;

AND WHEREAS, on this date, in public meeting, said Trustees have again considered the issue of said annexation;

NOW THEREFORE, BE IT RESOLVED, that each and every one of the following parcels of property are hereby annexed into the municipal limits of the Town of Sawyer, Choctaw County, Oklahoma:

Parcel 1 - Starting at the point where the current Town boundary crosses U.S. 70 in Section 25, Township 6 South, Range 18 East, in Choctaw County, Oklahoma, thence West along U.S. 70 from the North to the South edge of said Highway's right-of-way to the West edge of Section 26, Township 6 South, Range 18 East, in Choctaw County, Oklahoma;

Parcel 2 - The N $\frac{1}{2}$ of the N $\frac{1}{2}$ of Section 34, Township 6 South, Range 18 East, in Choctaw County, Oklahoma, and extending to the West edge of the Fallon Road right-of-way which is adjacent to said parcel;

Parcel 3 - All property located in the NW $\frac{1}{4}$ of Section 27, Township 6 South, Range 18 East, in Choctaw County, Oklahoma, which is located South of the platted lots owned by Deer Run Land Development Group, Inc.;

Parcel 4 - All property located in the SW¼ of Section 27, Township 6 South, Range 18 East, in Choctaw County, Oklahoma, then extending West along the north side of the U.S. 70 right-of-way to the point where Fallon Road intersects with U.S. 70, then extending South along the West edge of the Fallon Road right-of-way to a point opposite the NW corner of Section 34, Township 6 South, Range 18 East, in Choctaw County, Oklahoma.

AND BE IT FURTHER RESOLVED that the Final Service Plan for said annexed territory, as reflected in the Minutes of today's Town Council Meeting, is hereby incorporated into and made a part of this resolution.


