

ORDINANCE NO. 2000-1

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE TOWN OF SEILING, OKLAHOMA, AND DESIGNATING THE AREAS OR TRACTS INCLUDED IN SUCH EXTENSION; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith; PROVIDING THAT IF ANY PART OR PARTS HEREOF BE HELD INVALID OR INEFFECTIVE THE REMAINING PORTIONS SHALL NOT BE AFFECTED; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE TOWN OF SEILING, OKLAHOMA;

SECTION 1. PROPERTY ANNEXED. That the corporate limits of the Town of Seiling, Oklahoma, shall be, and the same are hereby extended to include the following described lands situated in Dewey County, Oklahoma, to-wit:

Lot Three (3) and the Southeast Quarter (SE/4) of the Northwest Quarter (NW/4) of Section Five (5), Township Nineteen (19) North, Range Sixteen (16) W.I.M., Dewey County, State of Oklahoma, less and except a tract of land commencing at the Northeast corner of said Lot 3, thence West along Section line 660 feet, thence South 990 feet, thence East 660 feet to the half section line, thence North along the half section line or the East line of Lot 3 as above described, to the place of beginning, containing approximately 15 acres.

SECTION 2. AUTHORITY. The Mayor and the Board of Trustees of the Town of Seiling, Oklahoma find that the above described property is adjacent and contiguous to the existing corporate limits of the Town of Seiling, Oklahoma; and that a petition has been filed and submitted to the Board of Trustees of the Town of Seiling, Oklahoma by at least three-fourths of the registered voters and the owners of at least three-fourths (in value) of the above described property requested to be annexed; and that notice of the presentation of such petition for annexation has been published by the Dewey County Publishing Company once each week for two (2) consecutive weeks, such publishing dates being June 29, 2000 and July 6, 2000, and that the Dewey County Publishing Company published said notice in a newspaper of general circulation in the Town of Seiling, Oklahoma. Annexation of the above described property by Ordinance is therefore authorized by Title 11, Oklahoma Statutes, Section 21-105.

SECTION 3. REPEALING CLAUSE. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION 4. SEVERANCE. If any part or parts hereof be held invalid or ineffective, the remaining portion shall be effective.


