

**TOWN OF SKIATOOK
ORDINANCE NO. 2008-04**

AN ORDINANCE REPEALING ORDINANCE NO. 2007-02, IN ITS ENTIRETY, AND ANNEXING TO THE TOWN OF SKIATOOK TERRITORY ADJACENT OR CONTIGUOUS TO THE CORPORATE LIMITS OF THE TOWN OF SKIATOOK, OKLAHOMA; FINDING JURISDICTIONAL FACTS; ASSIGNING THE ANNEXED LAND TO A WARD OF THE TOWN; ASSIGNING A ZONING CLASSIFICATION TO THE LAND ANNEXED; PROVIDING FOR SEPARABILITY; PROVIDING FOR CODIFICATION AND ESTABLISHING AN EFFECTIVE DATE.

Whereas, it is deemed desirable by the Board of Trustees of the Town of Skiatook that the tract of land more particularly described hereinafter be annexed within the municipal limits of the Town of Skiatook, Oklahoma, and said land being adjacent thereto, and

Whereas, all things necessary and proper for the annexation within the municipal limits of the Town of Skiatook and the inclusion therein of the tracts of land more particularly hereinafter described having been done and performed, and

Whereas, it is deemed desirable and beneficial for the citizens of the Town of Skiatook, Oklahoma, that the tract of land hereinafter described be included within the municipal limits of and made a part thereof,

BE IT, THEREFORE, ORDAINED BY THE BOARD OF TRUSTEES OF THE INCORPORATED TOWN OF SKIATOOK, STATE OF OKLAHOMA, DULY ASSEMBLED:

Section 1. Repealer. Ordinance 2007-02, in its entirety, are hereby repealed and in its stead such sections are hereby amended and reenacted to read in words as hereinafter indicated:

Section 2. Annexation. That the following described real estate be and the same is hereby annexed to the incorporated Town of Skiatook:

SW NE NE of Section 32, Township 22 North, Range 13E

SE NE of Section 32, Township 22 North, Range 13 East

SW SW NW of Section 33, Township 22 North, Range 13 East

SE SW NW and SE NW of Section 33, Township 22 North, Range 13 East

SE SE SW of Section 33, Township 22 North, Range 13 East

Beginning SE/C W/2 SW SW of section 33, Township 22 North Range 13 East; thence East along the South line of said Section 33 to the SW/C of E/2 of said Section; thence North along the West line of said E/2 a distance of 20 feet; thence West and parallel with the South line of said Section 33 to a point on the East boundary of W/2 SW SW;

thence South along the East boundary of W/2 SW SW a distance of 20 feet to the point of beginning.


Section 3. Publication. Within ten days from the date hereof this Ordinance shall be published at least once in the Skiatook Journal, a newspaper of general circulation in the municipality; and in publishing the ordinance the publisher or managing officer of the newspaper shall prefix to the ordinance a line in brackets stating the date of publication as "Published _____," giving the month, day, and year of publication.

Section 4. Ward Designation; Zoning. The area annexed by this ordinance shall become a part of Ward 1 of the Town of Skiatook and shall be assigned zoning classification AG.

Section 5. Effective Date. This ordinance shall become effective thirty (30) days after the date hereof, that being the date of its final passage.

Section 6. Codification. This ordinance shall be entered in the ordinance book of the Town of Skiatook immediately, which entry shall contain the text hereof and state the date of its passage, the page of the journal containing the record of the final vote on its passage and also the name of the newspaper in which the ordinance was published, and shall be codified in the Revised Ordinances of the Town of Skiatook as in the preface thereto under "Annexation Ordinances" Osage County, excluding from the codification this section.


