AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE TOWN OF SPERRY, OKLAHOMA, ACCEPTING, ADDING AND ANNEXING TO THE TOWN OF SPERRY, OKLAHOMA THE FOLLOWING DESCRIBED REAL PROPERTY AND DECLARING AN EMERGENCY

WHEREAS, the petitioners, the property owners of 100% of the described property, petitions the Board of Trustees of the Town of Sperry, Oklahoma, to annex the property adjacent to the City Limits of the Town of Sperry, Oklahoma.

WHEREAS, this petition is filed in accordance with Title 11 of the Oklahoma Statutes §21-105. Notice of this Petition having been published on November 21, 2001 and November 28, 2001(2 successive weeks) in The Skiatook Journal (a newspaper of general circulation in the municipality where the petition has been presented.)

WHEREAS, This Petition has been filed and presented by 100% of the owners and registered voters of the Real Property. Petitioners request that said real property be accepted, added and annexed to the Town of Sperry, Oklahoma.

BE IT ORDAINED, that the following described Real Property is accepted, added and annexed to the Town of Sperry, Oklahoma.

The West Half of the South Half of the North Half of the Southeast Quarter of the Northeast Quarter (S/2, N/2, SE/4, NE/4) of Section 20, Township 21 North, Range 13 East of the Indian Base and Meridian, Tulsa County, Oklahoma, according to the U. S. Government Survey thereof, containing five (5) acres and....

The East Half of the South Half of the North Half of the Southeast Quarter of the Northeast Quarter, LESS the North 80 feet of the East 490 feet AND the South 62 feet of the North 142 feet of the East 70 feet of the East Half of the South Half of the North Half of the Southeast Quarter of the Northeast Quarter, all in Section 20, Township 21 North, Range 13 East, Tulsa County, Oklahoma. Containing 4 acres, more or less AND..

The North 80 feet of the East 490 feet and the South 62 feet of the North 142 feet of the East 70 feet of the East Half of the South Half of the North Half of the Southeast Half of the Northeast Quarter of Section 20, Township 21 North, Range 13 East, Tulsa County, Oklahoma. 


