ORDINANCE NO. 2007-002
(This Ordinance amends Ordinance 2002-03)

AN ORDINANCE ANNEXING REAL PROPERTY LOCATED IN SECTION 1, TOWNSHIP 3 SOUTH, RANGE 1 EAST, CARTER COUNTY, OKLAHOMA, TO THE TOWN OF SPRINGER; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF SPRINGER:

WHEREAS, Jud Little, the owner of the real property hereinafter described has, by written letter to the Town of Springer, requested that annexation of said real property into the boundaries of the Town of Springer; and

WHEREAS, the Town of Springer agrees to the annexation of said real property into its boundaries.

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF SPRINGER, OKLAHOMA:

That the boundaries of the Town of Springer, Carter County, Oklahoma, be and the same are hereby extended so as to include the real property described as follows:

- * Lot 1 a/d/a NE/4 NE/4 (Less and except a tract of land out of the NE/4 NE/4 NE/4 containing approximately 2.9 acres), containing 37.12 acres
- * Lot 2 a/d/a NW/4 NE/4, containing 40.08 acres
- * Lot 3 a/d/a NE/4 NW/4, containing 40.12 acres
- * SE/4 NW/4, containing 40 acres
- * S/2 NE/4, containing 80 acres
- * N/2 SE/4, containing 80 acres
- * N/2 S/2 SE/4, containing 40 acres
- * S/2 SE/4 SE/4, containing 20 acres
- * W/2 E/2 SW/4 (lying east of I-35), containing approx. 20 acres
- * E/2 NE/4 SW/4, containing 20 acres
- * NE/4 SE/4 SW/4, containing 10 acres

BE IT FURTHER ORDAINED that the above-described real property, while being annexed into the boundaries of the Town of Springer, shall be zoned commercial.

WHEREAS, it being immediately necessary for the preservation of the peace, health, safety and public good of the Town of Springer and the inhabitants thereof, that the provision of this Ordinance be put into full force and effect, an emergency is hereby declared to exist by reason whereof this Ordinance shall take effect and be in full force from and after the date provided herein as provided by law.
