AN ORDINANCE ANNEXING THE PROPERTY DESCRIBED BELOW INTO THE CITY LIMITS OF THE CITY OF STIGLER, OK, AND ZONING THE PROPERTY DESCRIBED BELOW TO C-3 HIGHWAY BUSINESS DISTRICT; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND DECLARING AN EMERGENCY.

Be it ordained by the Mayor and City Council of the City of Stigler, Oklahoma:

SECTION 1: That there has been a request that certain property be annexed into the City of Stigler, OK, and that the property be zoned C-3 Highway Business District, which property is as described as set forth on the attached Exhibit "A" (the "property").

SECTION 2: That the property is therefore annexed into the City of Stigler, Haskell County, OK, and is zoned C-3 Highway Business District. That this annexation and zoning is done under the condition and with the provision that the City of Stigler is under no obligation to provide water and sewer services to the property or to provide any other utility services.

SECTION 3: That all ordinances or parts of ordinances in conflict herewith be, and the are hereby repealed.

SECTION 4: For the purpose of protecting and promoting the public health, safety, and welfare of said City and its inhabitants, it is hereby declared that an emergency exists by reason whereof this ordinance shall become effective immediately upon its passage and approval, as required by law.

PASSED AND APPROVED, and the emergency voted on separately and passed, on this 11th day of April, 2005.




A tract of land lying in the NW/4 SW/4 of Section 17, Township 9 North Range 21 East, I.M. in Haskell County, Oklahoma, described as:— Beginning at a point 1713.55 feet N 0° 03' W and 655 feet N 89° 57' East of the Southwest corner of said Section 17, said point being on the Northerly right of way line of the Ft. Smith Military Road; thence N 0° 22' 30" W a distance of 347 feet to the Easterly right of way line of Oklahoma State Highway 9; thence N 47° 33' 30" E along said Easterly right of way a distance of 149.5 feet; thence N 89° 49' 30" E a distance of 282 feet; thence S 0° 04' 30" E a distance of 568 feet to the Northerly right of way of the Ft. Smith Military Road; thence N 73° 22' 30" W along said Northerly right of way, a distance of 409.9 feet to the point of beginning, containing 4.45 acres, more or less
