

ORDINANCE NO. 2809



"AN ORDINANCE ADDING TO AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF STILLWATER, OKLAHOMA, TO INCLUDE AN AREA LOCATED AT THE SOUTHEAST CORNER OF 32ND AVENUE AND SOUTH MAIN STREET, KNOWN AS 101 EAST 32ND AVENUE."

BE IT ORDAINED BY THE MAYOR AND CITY COMMISSIONERS OF THE CITY OF STILLWATER, OKLAHOMA:

SECTION 1: That the corporate limits of the City of Stillwater, Oklahoma, a municipal Corporation, be and the same are hereby extended by adding to and including the following described property situated in Payne County, Oklahoma:

Section 35, T19N, R2E of the Indian Meridian, Payne County, Oklahoma, beginning 460 feet East of the NW corner of the NE/4, thence South 333 feet, thence East 300 feet, thence North 333 feet, thence West 300 feet to the Point of Beginning.

SECTION 2: That the Board of Commissioners finds that the above described property is adjacent or contiguous to property already within the corporate limits of the City of Stillwater; that the owners of the said property are registered voters of the State of Oklahoma who requested annexation by petition; and, that notice of said request was published as provided by law. The map of the Area of Annexation as shown on Exhibit "A" are hereby incorporated and made part of this ordinance by reference.

SECTION 3: That the City Clerk for the City of Stillwater, Oklahoma, is hereby authorized, directed and ordered to cause there to be filed and recorded a duly certified copy of this Ordinance No. 2809, together with an accurate map or plat of the above-described property, in the office of the County Clerk of Payne County, State of Oklahoma, as provided by law.
