ORDINANCE NO. 2833

"AN ORDINANCE ADDING TO AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF STILLWATER, OKLAHOMA, TO INCLUDE A SINGLE PROPERTY LOCATED IN THE 3100 TO 3300 BLOCKS OF WEST 32ND AVENUE"

BE IT ORDAINED BY THE MAYOR AND CITY COMMISSIONERS OF THE CITY OF STILLWATER, OKLAHOMA:

SECTION 1: That the corporate limits of the City of Stillwater, Oklahoma, a municipal Corporation, be and the same are hereby extended by adding to and including the following described property situated in Payne County, Oklahoma:

A tract of land in the West Half (W/2) of the East Half (E/2) of the Northwest Quarter (NW/4) of Section Thirty-three (33), Township Nineteen (19) North, Range Two (2) East of the Indian Meridian, Payne County, Oklahoma, more particularly described as follows: Commencing at the Northeast Corner (NE/cor) of said Northwest Quarter (NW/4), thence North 89° 18' 00" West along the Section boundary a distance of 717.23 feet to the point of beginning, thence South 00° 04' 39" East a distance of 1341.21 feet, thence South 89° 28' 13" West a distance of 597.52 feet, thence North 00° 03' 50" West a distance of 1342.96 feet to the Northwest Corner (NW/cor) of said West Half (W/2) of the East Half (E/2) of the Northwest Quarter (NW/4), thence South 89° 18' 00" East along the Section boundary a distance of 597.23 feet to the point of beginning.

SECTION 2: That the Board of Commissioners finds that the above described property is adjacent or contiguous to property already within the corporate limits of the City of Stillwater; that the owners of the said property are registered voters of the State of Oklahoma who requested annexation by petition; and, that notice of said request was published as provided by law. The map of the Area of Annexation as shown on Exhibit "A" are hereby incorporated and made part of this ordinance by reference.

SECTION 3: That the City Clerk for the City of Stillwater, Oklahoma, is hereby authorized, directed and ordered to cause there to be filed and recorded a duly certified copy of this Ordinance No. 2833, together with an accurate map or plat of the above-described property, in the office of the County Clerk of Payne County, State of Oklahoma, as provided by law.
