ORDINANCE NO. 311

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY AND DESIGNATING SUCH TERRITORY AS NEW HAVEN ADDITION TO THE CITY OF STILWELL, OKLAHOMA; AND DECLARING AN EMERGENCY.

BE IT ORDAINED, by the Mayor and Council of the City of Stilwell, Oklahoma:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to-wit:

A parcel of land containing 5.07 acres, more or less, located in the SW NE of Section 34, Township 16 North, Range 25 East of the I.B. & M., Adair County, Oklahoma, being more particularly described as follows: The East 470.00 feet of the North 470.00 feet of a tract of land beginning 30 rods (495 feet) South of the NE corner of SW/4 NE/4 of said Section 34, running West 80 rods (1320 feet) to the West line of the SW NE; thence South along the West line of the SW NE 50 rods (815 feet) to the SW corner of the SW NE; thence East 80 rods (1320) along the South line of the SW NE to the SE corner of the SW NE; thence North along the East line of the SW NE 50 rods (825 feet) to the point of beginning, subject to road rights of way

a plat of which said property is attached hereto and made a part hereof as though described herein.

SECTION 2. That the real property herein described shall be designated as the New Haven Addition to the City of Stilwell, Oklahoma, and the boundaries of said City are hereby changed to correspond to the legal description first above given.

SECTION 3. That all ordinances, parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. WHEREAS, an immediate necessity exists therefor, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force and effect from and after its passage and approval.


