ORDINANCE NO. 313

**AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY AND DESIGNATING SUCH TERRITORY AS CLEAR WATER ESTATES ADDITION TO THE CITY OF STILWELL, OKLAHOMA.**

**BE IT ORDAINED**, by the Mayor and Council of the City of Stilwell, Oklahoma:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to-wit:

A tract of land beginning 30 rods (495 feet) South of the NE corner of the SW NE of Section 34, Township 16 North, Range 25 East, running West 80 rods (1320 feet) to the West line of SW NE; thence South along the West line of SW NE, 50 rods (825 feet) to the SW corner of the SW NE; thence East 80 rods (1320 feet) along the South line of SW NE to the SE corner of SW NE; thence North along the East line of SW NE 50 rods (825 feet) to the point of beginning, containing 25 acres more or less, and subject to road right of way, LESS AND EXCEPT: The East 470.00 feet of the North 470.00 feet of the above described tract situated in the SW NE of Section 34, Township 16 North, Range 25 East, containing 19.895 acres, more or less

a plat of which said property is attached hereto and made a part hereof as though described herein.

SECTION 2. That the real property herein described shall be designated as the **CLEAR WATER ESTATES ADDITION** to the City of Stilwell, Oklahoma, and the boundaries of said City are hereby changed to correspond to the legal description first above given.

SECTION 3. That all ordinances, parts of ordinances in conflict herewith are hereby repealed.


