AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STROUD, OKLAHOMA AND DESIGNATING THE AREA OR TRACT INCLUDED IN SUCH EXTENSION; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING THAT IF ANY PART OR PARTS HEREOF BE HELD INVALID OR INEFFECTIVE THE REMAINING PORTIONS SHALL NOT BE AFFECTED; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF STROUD, OKLAHOMA:


SECTION 1. That the corporate limits of the City of Stroud, Oklahoma, shall be and the same are hereby extended to include the following described land situated in Lincoln County, Oklahoma, to-wit:

TRACT 1 (CURRY)

The E/2 E/2 E/2 SW/4 of Section 34-15N-6E, containing 20 acres, more or less.

TRACT 2 (LEWIS)

The South 1954 feet of the West 330 feet of the SE/4 of Section 34-15N-6E, containing 14.73 acres, more or less.



SECTION 2. The Council finds that the above described areas are adjacent and contiguous to the present corporate limits of said City and that such annexation has been consented to in writing by owners of a majority of the whole number of acres owned by residents of the said territories to be annexed; and that the annexation of said areas is authorized by the Statutes of the State of Oklahoma, and in particular by Sections 21-102 and 21-103 of Title 11 Oklahoma Statutes, as supplemented.

SECTION 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. If any part or parts hereof be held invalid or ineffective the remaining portions shall not be affected.

SECTION 5. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared by reason whereof this ordinance shall be in full force and effect from and after its passage and approval as by law provided.


