ORDINANCE NO. 1052-2004

AN ORDINANCE EXTENDING THE BOUNDARIES OF THE CITY OF TAHLEQUAH, CHEROKEE COUNTY, OKLAHOMA, TO INCLUDE THEREIN THE HEREINAFTER DESCRIBED PIECE OR PARCEL OF LAND TO THE CITY OF TAHLEQUAH, CHEROKEE COUNTY, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF TAHLEQUAH, OKLAHOMA, IN SESSION ASSEMBLED

LAND DESCRIPTION:

A tract of land lying in and being a part of the SE1/4 SW1/4 of Section 3, Twp. 16 N, Rge. 22 E, Cherokee County, Oklahoma, more particularly described as follows, to-wit: Beginning at a point on the North boundary and 330.0 feet West of the Northeast corner of said SE1/4 SW1/4; thence S 0°-14'-52" W, 900.23 feet; thence S 89°-57'-44" W, 296.13 feet; thence S 0°-14'-52" W, 87.42 feet; thence S 89°-57'-44" W, 679.85 feet; thence N 0°-02'-16" W, 988.48 feet to a point on the North boundary of said SE1/4 SW1/4; thence S 89°-59'-19" E, 980.9 feet to the Point of Beginning. Containing 21.6 acres, more or less

Section 1.

WHEREAS, the real estate described above and incorporated herein by this reference as though fully set forth herein, with the unanimous written consent of the owners in accordance with Okla. Stat. Tit. 11 §§ 21-103 and 21-105, and finding having been made by the Council of the City of Tahlequah, Oklahoma, that the annexation of said real estate would be desirable to the City of Tahlequah, Oklahoma.

Section 2.




Section 3.
