AN ORDINANCE EXTENDING THE BOUNDARIES OF THE CITY OF TAHLEQUAH, CHEROKEE COUNTY, OKLAHOMA, TO INCLUDE THEREIN THE HEREINAFTER DESCRIBED PIECE OR PARCEL OF LAND TO THE CITY OF TAHLEQUAH, CHEROKEE COUNTY, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF TAHLEQUAH, OKLAHOMA, IN SESSION ASSEMBLED:

LAND DESCRIPTION

A tract of land lying in and being a part of the W 1/2 NE 1/4 NW 1/4 of Section 32, T17N, R22E of the IB&M, more particularly described as follows, to-wit: **BEGINNING** at a point on the West boundary and 462.2 feet South of the Northwest corner of said W 1/2 NE 1/4 NW 1/4; thence S 0° 17' 10" E, along the West boundary of said W 1/2 NE 1/4 NW 1/4, 463.08 feet; thence S 89° 52' 51" E, 128.0 feet; thence N 0° 16' 12" W, 168.57 feet; thence S 85° 15' 37" E, 254.14 feet; thence N 59° 20' 14" E, 39.47 feet; thence N 08° 47' 26" E, 63.93 feet; thence N 02° 32' 17" W, 230.84 feet; thence 89° 44' 49" W, 416.29 feet to the **POINT OF BEGINNING**, Cherokee County, Oklahoma.


Section 1.


