**AN ORDINANCE OF THE CITY OF TISHOMINGO, OKLAHOMA,
ANNEXING CERTAIN LANDS WITHIN THE CORPORATE LIMITS
OF THE CITY OF TISHOMINGO, AND DECLARING AN EMERGENCY**



BE IT ORDAINED by the City Council of the City of Tishomingo, Oklahoma, as follows:

SECTION 1. Annexation.

The corporate limit of the City of Tishomingo is hereby expanded to include the following property, to-wit:

A tract of land located in the NE1/4 NE1/4 NW1/4 Section 5, Township 4 South, Range 6 East and the SW1/4 of Section 32, Township 3 South, Range 6 East of the I.B.M., Johnston County, Oklahoma, described more particularly as follows:
Beginning at the NE corner NW1/4 of said Section 5; Thence S00 degrees 16'00"E along the East line of the NW1/4 of said Section 5, 520.97 feet; Thence N89 degrees 53'00"W 626.00 feet; Thence N00 degrees 15'54"W 522.83 feet to a point on the North line of said Section 5, being S89 degrees 42'48"E 626.00 feet from the POINT OF BEGINNING; Thence N00 degrees 10'46"E 1427.87 feet; Thence S89 degrees 49'14"E 626.00 feet to a point on the East line of said Sec. 32; Thence S00 degrees 10'46"W 1429.04 feet to the POINT OR PLACE OF BEGINNING.

A tract of land being a part of the Southwest Quarter of the Northwest Quarter of Section 34, Township 3 South, Range 6 East, Indian Base and Meridian, Johnston County, Oklahoma, more particularly described as follows:
Commencing from the Northwest Corner of said Section 34; Thence S00 degrees 02'59"W, a distance of 1322.77 feet along the West line of Section 34 to the POINT OF BEGINNING, said point being the Northwest Corner of the SW1/4 of the NW1/4; Thence N89 degrees 56'27"E a distance of 640.59 feet along the North line of the SW1/4 of the NW1/4 of Section 34; Thence S00 degrees 02'59"W, a distance of 340.0 feet; Thence S89 degrees 56'27"W, a distance of 640.59 feet to a point on the West line of Section 34; Thence N00 degrees 02'59"E, a distance of 340.0 feet along said West line to the POINT OF BEGINNING.
