



ORDINANCE NO. 2006 - 28

AN ORDINANCE OF THE CITY OF TISHOMINGO, OKLAHOMA, CLOSING THAT PORTION OF FIFTH STREET BETWEEN NORTH NESHOBA STREET AND BROADWAY STREET AND BOUNDED ON THE NORTH BY BLOCK 23 AND ON THE SOUTH BY BLOCK 38 WITHIN THE CITY LIMITS OF TISHOMINGO, OKLAHOMA AND THE ALLEY LYING WITHIN BLOCK 23 AND BOUNDED BETWEEN LOTS 1-4 IN BLOCK 23 TO THE WEST AND LOTS 5-8 TO THE EAST WITHIN THE CORPORATE LIMITS OF THE CITY OF TISHOMINGO AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the City Council of the City of Tishomingo, Oklahoma, as follows:

SECTION 1. The street and alley described below, all lying within Johnston County, Oklahoma, is within the current corporate limits of the City of Tishomingo:

THAT PORTION OF FIFTH STREET BETWEEN NORTH NESHOBA STREET AND BROADWAY STREET AND BOUNDED ON THE NORTH BY BLOCK 23 AND ON THE SOUTH BY BLOCK 38 WITHIN THE CITY LIMITS OF TISHOMINGO, OKLAHOMA AND THE ALLEY LYING WITHIN BLOCK 23 AND BOUNDED BETWEEN LOTS 1-4 IN BLOCK 23 TO THE WEST AND LOTS 5-8 TO THE EAST.

Notice has been given to all franchise holders and others that may have a special right or interest to use the public way within the City of Tishomingo, Oklahoma, at least thirty (30) days prior to the enactment of this ordinance.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TISHOMINGO:

THAT PORTION OF FIFTH STREET BETWEEN NORTH NESHOBA STREET AND BROADWAY STREET AND BOUNDED ON THE NORTH BY BLOCK 23 AND ON THE SOUTH BY BLOCK 38 WITHIN THE CITY LIMITS OF TISHOMINGO, OKLAHOMA AND THE ALLEY LYING WITHIN BLOCK 23 AND BOUNDED BETWEEN LOTS 1-4 IN BLOCK 23 TO THE WEST AND LOTS 5-8 TO THE EAST WITHIN THE CITY OF TISHOMINGO, JOHNSTON COUNTY, OKLAHOMA IS HEREBY CLOSED, WITH EASEMENTS RESERVED TO FRANCHISE HOLDERS.

SECTION 2. Severability.

If any section, subsection, sentence, clause, phrase, or portion of the Ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, said portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portion of this Ordinance.
