AN ORDINANCE PROVIDING FOR THE ANNEXATION
OF TERRITORY ADJACENT TO THE CITY LIMITS
OF THE CITY OF TISHOMINGO, OKLAHOMA

BE IT ORDAINED by the Mayor and City Council of the City of Tishomingo, Oklahoma, that a resolution has been passed by the City of Tishomingo, requesting that the hereinafter described real property be annexed into the City of Tishomingo and that all provisions of 11 O.S. Section 21-103(B) have been complied with, and the territorial limits of Tishomingo, Oklahoma, are hereby extended by annexation of the following adjacent land to Tishomingo, Oklahoma, to-wit:

1-202
A tract of land in SE/4 NE/4, containing 2.84 acres, more or less, described as follows: Beginning at the point of intersection of the Northeasterly right-of-way line of a county road with the East line of Section 10, said point being 2171 feet South of the Northeast corner of Section 10; thence North along the East line of Section 10, 584.6 feet; West, 272 feet; South 324 feet; South 46 Degrees 13 Minutes East, along the Northeasterly right-of-way line of county road, 377 feet to the place of beginning, Section 10, Township 4 South, Range 6 East, of the Indian Meridian, Johnston County, Oklahoma; AND

A tract of land in the SE/4 NE/4 of Section 10, Township 4 South, Range 6 East, described as follows: Beginning at the SE Corner of the SE/4 NE/4 thence North along the East line of said Section 10, a distance of 269 feet; thence North 46 Degrees 13' West along the Northeasterly right of way line of the county road 377 feet; thence South to the South line of the said SE/4 NE/4 a distance of 729.6 feet; thence East a distance of 272 feet to the point of beginning;

said tracts being adjacent to and abutting a portion of the East, South, and North boundary lines of the city limits of Tishomingo, Oklahoma; and the council finding that Notice of Annexation by Publication has been given as required by law.

BE IT FURTHER ORDAINED that pursuant to 11 O.S. Section 21-103(B)(3) the above described annexed real property shall be serviced by providing police protection and monitoring together with mowing.

BE IT FURTHER ORDAINED that there will be no charge for the purchase of cemetery lots on the above described lands.

BE IT FURTHER ORDAINED that it being necessary for the preservation of the public health, peace and safety, an emergency is hereby declared to exist, by reason whereof this ordinance shall be in full force and effect from and after its passage and approval.
