AN ORDINANCE PROVIDING FOR THE ANNEXATION
OF TERRITORY ADJACENT TO THE CITY LIMITS
OF THE CITY OF TISHOMINGO, OKLAHOMA

BE IT ORDAINED by the Mayor and City Council of the City of Tishomingo, Oklahoma, that a resolution has been passed by the City of Tishomingo, requesting that the hereinafter described real property be annexed into the City of Tishomingo and that all provisions of 11 O.S. Section 21-103(B) have been complied with, and the territorial limits of Tishomingo, Oklahoma, are hereby extended by annexation of the following adjacent land to Tishomingo, Oklahoma, to-wit:

SEE ATTACHED EXHIBIT "A";
said tracts being adjacent to and abutting a portion of the East, South, and North boundary lines of the city limits of Tishomingo, Oklahoma; and the council finding that Notice of Annexation by Publication has been given as required by law.

BE IT FURTHER ORDAINED that pursuant to 11 O.S. Section 21-103(B)(3) the above described annexed real property shall receive those city services currently being provided.

BE IT FURTHER ORDAINED that it being necessary for the preservation of the public health, peace and safety, an emergency is hereby declared to exist, by reason whereof this ordinance shall be in full force and effect from and after its passage and approval.

EXHIBIT "A"

A piece, parcel and tract of land 300 feet North and South and 544.5 feet East and West adjoining and adjacent to the following described tract of land on the South side thereof, being a part of the W/2 of the NE/4 of the SE/4 of Section 9, Township 4 South, Range 6 East of the Indian Base and Meridian, described as follows:

Beginning at a point 20 feet South and 12.7 feet West, of the Northeast corner of the W/2 of the NE/4 of the SE/4 of Section 9, Township 4 South, Range 6 East, thence South $0^{\circ} 5'$ West a distance of 800 feet, thence West a distance of 544.5 feet, thence North $0^{\circ} 5'$ East a distance of 400 feet, thence East a distance of 326.7 feet, thence North $0^{\circ} 5'$ East a distance of 400 feet, thence East a distance of 217.8 feet, to the point of beginning. Containing 7.0 acres.

The said tract of land of 300 feet by 544.5 feet lying immediately adjacent to the above described tract of land and being more particularly described as follows: A part of the W/2 of the NE/4 of the SE/4 of Section 9, Township 4 South, Range 6 East, of said County and State, more particularly described as follows, to-wit:

Beginning at a point 12.7 feet West and 820 feet South $0^{\circ} 05' 00''$ of the Northeast corner of the said W/2; thence South $0^{\circ} 05' 00''$ West a distance of 300 feet; thence West a distance of 544.5 feet; thence North $0^{\circ} 05' 00''$ East a distance of 300 feet; thence East a distance of 544.5 feet to the point of beginning, containing 163,350 square feet (3.75 acres), more or less; and also
