

ORDINANCE NO. 2012-1

AN ORDINANCE DETACHING CERTAIN PROPERTY FROM WITHIN THE CORPORATE LIMITS OF THE TOWN OF TRYON, OKLAHOMA, AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith; PROVIDING THAT IF ANY PART OR PARTS HEREOF BE HELD INVALID OR INEFFECTIVE THE REMAINING PORTIONS SHALL NOT BE AFFECTED; AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Mayor and the Town Board of Trustees of the Town of Tryon, Oklahoma, as follows:

SECTION 1. That the following described property previously annexed into the corporate limits of the Town of Tryon, Oklahoma are hereby detached or de-annexed from the corporate limits of the Town of Tryon, Lincoln County, Oklahoma, to-wit:

TRYON TRS 2-16-3 N/2 SW/4 LESS TR BEG NW/C S-389' E-525' N-389' W-525' POB 75.23 AC MOL 16-3-2-300-017, and TRYON TRS 2-16-3 S/2 NW/4 LESS TR BEG NW/C E-650' S-514' W-300' S-776.5' TO S/L S/2 NW/4 W-350' N-1288' POB 16-3-2-200-005 66.10 AC

SECTION 2. The town Board of trustees finds that the de-annexation has been consented to in writing by owners of a majority of the whole number of acres owned by residents of said territories to be de-annexed; and that the de-annexation of said areas is authorized by the Statutes of the State of Oklahoma, and in particular by section 21-110 of title 11 Oklahoma Statutes, as supplemented.


SECTION 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. If any part or parts hereof be held invalid or ineffective, the remaining portions shall not be affected.


