ORDINANCE NO. 21546

AN ORDINANCE AMENDING ORDINANCE NO. 21528, PASSED AND ADOPTED BY THE COUNCIL OF THE CITY OF TULSA ON APRIL 5, 2007, APPROVED BY THE MAYOR ON MAY 11, 2007, AND PUBLISHED ON MAY 23, 2007, WHICH PROVIDED FOR THE ANNEXATION OF CERTAIN REAL PROPERTY AND TERRITORY, MORE PARTICULARLY DESCRIBED THEREIN; AMENDING SECTION 8 OF ORDINANCE NO. 21528, WHICH THEREIN PROVIDED THAT THE SUBJECT ANNEXATION SHALL BE EFFECTIVE ON AND AFTER SUNDAY, JULY 1, 2007; PROVIDING THAT SECTION 8 OF ORDINANCE NO. 21528, NOW SPECIFY THAT THE SUBJECT ANNEXATION SHALL BE EFFECTIVE ON AND AFTER THURSDAY, JANUARY 1, 2009; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 21528 was passed and adopted by the Council of the City of Tulsa on April 5, 2007, approved by the Mayor on May 11, 2007, and published on May 23, 2007, which therein provided that the subject annexation shall be effective on and after Sunday, July 1, 2007;

WHEREAS, a Memorandum of Understanding has been entered into by the Tulsa County Public Facilities Authority and the City of Tulsa, as executed by Authority Chairman Randi Miller and Mayor Kathy Taylor, and subsequently approved by the City Council by Resolution; and

WHEREAS, Ordinance No. 21528 should be amended to now provide that the subject annexation shall be effective on and after Thursday, January 1, 2009.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That Section 8 of Ordinance No. 21528 be and the same is hereby amended to read as follows:

"Section 8. ANNEXATION EFFECTIVE DATE. That on and after Thursday, January 1, 2009, the territory described in Section 7 of this Ordinance shall be a part of the City of Tulsa, Oklahoma, and all persons residing and property situated within the subject territory shall be and are hereby declared to be subject to the jurisdiction, laws, ordinances, and regulations of the City of Tulsa, Oklahoma,


in all respects and particulars. Establishment of the effective date of this annexation is predicated upon the Memorandum of Understanding entered into by the Tulsa County Public Facilities Authority and the City of Tulsa, as executed by Authority Chairman Randi Miller and Mayor Kathy Taylor, with the intent that the Memorandum of Understanding will be fully implemented by subsequent ordinances of the City and pursuant to all parties acting in good faith and with fair dealing."

Section 2. EMERGENCY CLAUSE. That an emergency is now declared to exist for the preservation of the public peace, health and safety, by reason whereof this ordinance shall take effect immediately from and after its passage, approval and publication.


