

**ORDINANCE NO. 2014-1**

AN ORDINANCE OF THE TOWN OF TUSHKA, OKLAHOMA,  
ANNEXING CERTAIN LANDS WITHIN THE CORPORATE  
LIMITS OF THE TOWN OF TUSHKA.

WHEREAS, the property described below, all lying within Atoka County, Oklahoma, is adjacent to the current corporate limits of the Town, insofar as it does not currently lie within the current corporate limits of the Town, to-wit:

All that portion north of the south right-of-way and south of the north right-of-way of Boggy Depot Road, insofar as it lies east of the west line of Sections 5 and 8, Township 3 South, Range 11 East of the Indian Base and Meridian.

All the portion east of the west right-of-way and west of the east right-of-way of U.S. Highway 69/75, insofar as it lies north of the north bank of Frontierhouse Creek at the point where said creek crosses said right-of-way, said property lying within Sections 7, 8, 17 and 18 of Township 3 South, Range 11 East of the Indian Base and Meridian.

and,

WHEREAS, notice has been published and mailed as required by applicable law regarding the annexation of said property, and

WHEREAS, prior to the publication of said notice, a plan to extend appropriate town services to the said property has been prepared, said plan complying fully with applicable law, and said plan has been available for public inspection as required by applicable law, and

WHEREAS, the said property has an assessed valuation less than the assessed valuation of the Town, and

WHEREAS, a public hearing was held as required by applicable law on the 6<sup>th</sup> day of February, 2014, regarding annexation of the said property, and proper notice was given of said hearing as required by applicable law, and

WHEREAS, annexation of the said property will benefit the Town and will serve the public interest, and

NOW, THEREFORE, be it ordained by the Board of Trustees of the Town of Tushka, Oklahoma, that the property described above is hereby annexed to and made a part of the corporate limits of the Town of Tushka, insofar as it was not previously within the corporate limits of the Town, pursuant to 11 O.S. § 21-104.

Additionally, the Plan for Extension of Municipal Services to Territory Annexed to the Town of Tushka, Oklahoma, which is attached hereto, is incorporated herein and made a part hereof by reference.

The Ordinance was declared adopted on the 6<sup>th</sup> day of February, 2014.


