AN ORDINANCE CORRECTING ORDINANCE 2003-07 WHICH ANNEXES CERTAIN TERRITORY INTO THE CORPORATE LIMITS OF THE TOWN OF VERDIGRIS, OKLAHOMA, BY CORRECTING A CLERICAL ERROR IN THE LEGAL DESCRIPTION, SETTING FORTH THE CORRECTED LEGAL DESCRIPTION, AND DECLARING AN EMERGENCY.

WHEREAS, the Town of Verdigris, Oklahoma (the "Town"), did on the 21<sup>st</sup> day of January, 2003, adopt a Service Plan For Extending Services To Territory Proposed For Annexation ("Service Plan") proposing to adopt the territory described on the attached Exhibit "A" which is the correct legal description of the affected territory, such territory being adjacent and contiguous to the corporate limits of the Town of Verdigris;

WHEREAS, the required mailing and publishing of notice was provided, and thereafter the Town Board held a public hearing on the 20<sup>th</sup> day of March, 2003, and took public comment regarding the annexation of the property annexed therein;

WHEREAS, the Town thereafter on the 20<sup>th</sup> day of March, 2003, did annex the territory described on Exhibit "A" into the Town pursuant to said Service Plan deeming same to be in the best interest of the Town. Such annexation was accomplished by the passage of Ordinance 2003-07, and attached thereto was a map depicting the correct property to be annexed; however, the legal description attached to said ordinance was incorrect;

WHEREAS, the Town Board of Trustees desires to correct the legal description contained in Ordinance 2003-07.

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF VERDIGRIS, OKLAHOMA:**

Section 1: That the legal description in Ordinance 2003-07 shall be corrected to read as follows:

**SEE EXHIBIT "A"**

Section 2: That the territory described in Exhibit "A", attached and incorporated by reference, be and the same is hereby deemed annexed to the Town of Verdigris, Oklahoma, by the passage of Ordinance 2003-07, as amended and corrected herein.

Section 3: That there shall be filed in the office of the County Clerk of Rogers County, Oklahoma, a true and certified copy of this Ordinance correcting Ordinance 2003-07, together with an accurate map of the territory hereby annexed.

Section 4: If any section, subsection or sentence, clause or phrase of this Ordinance is for any reason held invalid, such decision or decisions shall not affect the validity of the remaining portions of this Ordinance.

Section 5: The Service Plan for Extending Services to Territory Proposed for Annexation adopted by the Town Board and on file with the Town Clerk is hereby incorporated by reference as if set forth fully herein in the form originally adopted by the Town.

Section 6. For the preservation of the public peace, health, welfare and safety, an emergency is hereby declared to exist and by reason whereof this Ordinance shall become effective immediately upon its passage, approval and publication as required by law.


