

**AN ORDINANCE PROVIDING FOR ANNEXATION
TO THE TOWN OF VIAN, OKLAHOMA CERTAIN
PROPERTIES HEREINAFTER SET OUT:**

WHEREAS: The Town Board of Trustees of Vian, Oklahoma, (the "Board") in accordance with Oklahoma Statutes Title 11 Section 21 - 104, desire to annex the hereinafter described real estate, ("Property") which adjoins and is contiguous to the incorporated Town of Vian, Sequoyah County, Oklahoma, and not currently within the limits thereof, said "Property" being described as follows, to-wit:

In Section 22 Township 12 North Range 22 East, Sequoyah County, Oklahoma, thence beginning at the center line point of State Highway 82 where it intersects with Thompson Street proceeding North on Highway 82 from east to west ROW for approximately 6,254 feet to a point 38 feet W of the SW corner of NW NW NW Section 15 Township 12 North Range 22 East.

After due consideration, at a public hearing of the proposed annexation and following notice of the proposed annexation published in a legal newspaper of general circulation in Sequoyah County, Oklahoma, a copy of th Proof of Publication being attached hereto and labeled as Exhibit "A", giving notice of the intention of this annexation, the Board finds the publication is satisfactory and the Board is desirous of extending it's corporate limits to include the Property; and

WHEREAS; after due consideration by the Town Board of the Town of Vian, Oklahoma, a unanimous vote was cast in favor of annexation of the Property

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE Town of Vian, State of Oklahoma, be and the same hereby extended so as to hereinafter include the Property, contiguous to but not presently within said incorporated limits of said Town.

IT IS FURTHER ORDAINED that the above described Property constitute, from and after the date of this ordinance and the filing of a copy thereof, duly certified, together with an accurate map, with the County Clerk, as provided by law, a part of

the incorporated Town of Vian Oklahoma.

That this Ordinance shall be in full force and effect from and after its passage, approval and publications required by law.
