

**AN ORDINANCE PROVIDING FOR ANNEXATION  
TO THE TOWN OF VIAN, SEQUOYAH COUNTY  
OKLAHOMA CERTAIN PROPERTIES HEREINAFTER  
SET OUT:**

WHEREAS: There has been filed with the Town Council of the Town of Vian, Oklahoma (the "BOARD") petitions signed by more than 3/4 of the legal voters and by owners of more than 3/4 (in value) of the hereinafter described real estate ("Property") which adjoins and is contiguous to the incorporated Town of Vian, Oklahoma, and not embraced within the limits thereof, asking that the corporate limits of said Town be extended so as to include said property, said property being described as follows, to-wit and in accordance with Oklahoma Statute Title, Section 21-105.

In Section 27 T12N R22E all of the SW NE NW and the S/4 NW NE NW.. This includes Parcels 003, 024, 026, 027, 031, 032, 034, 035, 037, 039, 040 and 045.

WHEREAS: after due consideration, at a public hearing of the proposed annexation of said petitions, together with the proof of publication in a legal newspaper of general circulation in Sequoyah County, Oklahoma giving notice of the intention to present said petitions in accordance with law, the Council finds that said petitions and Proof of Publications ("Exhibit "A") are satisfactory and the Town Council is desirous of extending it's corporate limits to include the herein above described real property.

WHEREAS: A description of said property was approved by the County Valuation Section.

WHEREAS: A plan to extend appropriate Town services has been presented to the Board and, copy of the Plan attached hereto as Exhibit "B".

BE IT FURTHER ORDAINED that the Plan, as set forth in Exhibit "B". Is hereby adopted by the Board and shall be completed and implemented with the time periods set forth therein.

WHEREAS: after due consideration by the Town Board a unanimous vote was cast in favor of annexation of the Property.

That this Ordinance shall be in full force and effect from and after its passage , approval and publications required by law.


