



ORDINANCE NO. 3290

AN ORDINANCE ANNEXING TO THE CITY OF VINITA, OKLAHOMA, A CERTAIN TERRITORY HEREINAFTER MORE PARTICULARLY DESCRIBED; AND EXTENDING THE CITY LIMITS OF SAID CITY OF VINITA, OKLAHOMA, TO INCLUDE SAID TERRITORY; AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Vinita, Oklahoma, after public hearing has determined the corporate limits of the City of Vinita, Oklahoma, should be extended to include the territory hereinafter more particularly described; and

WHEREAS, the owners of the hereinafter described real property have heretofore expressly consented to the annexation of said property and agreed to come within the corporate limits of the City of Vinita, Oklahoma, said Consent to Annexation is attached hereto and made a part hereof by reference; and

WHEREAS, the Mayor and City Council of the City of Vinita, Oklahoma, have found that the annexation of said territory is desirable and in the best interests of the City of Vinita, Oklahoma, and that said property should be annexed to the City of Vinita, Oklahoma.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF VINITA:

Section 1: That the Corporate limits of the City of Vinita, Oklahoma, be and the same are hereby extended to include the lands and premises, more particularly described as follows, to-wit:

SEE LEGAL DESCRIPTION ATTACHED AS EXHIBIT "1"

Section 2: --The lands and premises hereinbefore described are hereby annexed to the City of Vinita, Oklahoma.

Section 3: That for the preservation of the public health, peace and safety of the citizens of the City of Vinita, an emergency is hereby declared to exist, by reason whereof, this Ordinance shall be in full force and effect from and after its publication and approval.

PASSED AND APPROVED by the Mayor and City Council of the City of Vinita, in regular session on this 6th day of December, 2005, with emergency clause approved separately.

EXHIBIT "1"

CITY OF VINITA – TERRITORY TO BE ANNEXED

TRACT 1-

The S/2 SE/4 SW/4 LESS AND EXCEPT the West 132 feet thereof, and LESS AND EXCEPT the South 349 feet of the East 660.89 feet of the West 792.89 feet thereof; of Section 19, Township 25 North, Range 20 East of the Indian Meridian, Craig County, State of Oklahoma, according to the United States Government Survey thereof.

TRACT 2-

All that part of the SE/4 SW/4 SW/4; and the S/2 SE/4 SW/4, lying South and East of Oklahoma Turnpike Authority Right-of-Way, which is described as follows: Beginning at a point on the South line of said SW/4 SW/4 470.5 feet East of the SW corner of said SW/4 SW/4, thence East along said South line a distance of 488.6 feet, thence Northeasterly on a curve to the left having a radius of 17,339.00 feet, a distance of 1,012.3 feet, to a point on the North line of said S/2 SE/4 SW/4, thence West along said North line a distance of 421.5 feet to the Northwest corner of said S/2 SE/4 SW/4, thence North along the East line of said SW/4 SW/4 a distance of 31.0 feet, thence Southwesterly on a curve to the right having a radius of 17,039.0 feet a distance of 1,094.7 feet to the Point of Beginning; AND all that part of said S/2 SE/4 SW/4; and all that part of the SW/4 SW/4 SE/4 lying South of the South line of Public Road, which South line is described as follows, to-wit: Beginning at the Southeast corner of the SW/4 SW/4 SE/4, thence North along the East line of said subdivision a distance of 75 feet to the South line of said Public Road, thence N 70° W to a point where the South line of said Public Road intersects the North line of the SW/4 SE/4 SW/4; all being in Section 23, Township 25 North, Range 20 East of the Indian Base and Meridian, Craig County, Oklahoma.

TRACT 3-

The SE/4 NE/4 SE/4 and the N/2 SE/4 SE/4 and the SE/4 SE/4 SE/4, all in Section 11, Township 25 North, Range-20 East of the Indian Base and Meridian, Craig County, State of Oklahoma.








