


ORDINANCE NO. 3458



**AN ORDINANCE ANNEXING TO THE CITY OF VINITA, OKLAHOMA, A CERTAIN TERRITORY HEREINAFTER MORE PARTICULARLY DESCRIBED; AND EXTENDING THE CITY LIMITS OF SAID CITY OF VINITA, OKLAHOMA, TO INCLUDE SAID TERRITORY; AND DECLARING AN EMERGENCY.**

**WHEREAS**, the owners of the hereinafter described real property have heretofore expressly requested the annexation of said property to come within the corporate limits of the City of Vinita, Oklahoma; and

**WHEREAS**, the City Council of the City of Vinita, Oklahoma, after public hearing has determined the corporate limits of the City of Vinita, Oklahoma, should be extended to include the territory hereinafter more particularly described; and

**WHEREAS**, the Mayor and City Council of the City of Vinita, Oklahoma, have found that the annexation of said territory is desirable and in the best interests of the City of Vinita, Oklahoma, and that said property should be annexed to the City of Vinita, Oklahoma with C-3 zoning.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF VINITA:**

**Section 1:** That the Corporate limits of the City of Vinita, Oklahoma, be and the same are hereby extended to include the lands and premises, more particularly described as follows, to-wit:

**The South Half of the Southeast Quarter of the Northeast Quarter of the Southeast Quarter of Section Twenty-two (22), Township Twenty-five (25) North, Range Twenty (20) East of Indian Meridian, Craig County, Oklahoma.**

**Section 2:** The lands and premises hereinbefore described are hereby annexed to the City of Vinita, Oklahoma with said tract to be zoned C-3, General Commercial District.

**Section 3:** That for the preservation of the public health, peace and safety of the citizens of the City of Vinita, an emergency is hereby declared to exist, by reason whereof, this Ordinance shall be in full force and effect from and after its publication and approval.

PASSED AND APPROVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF VINITA, OKLAHOMA, IN REGULAR SESSION ON THIS 16<sup>TH</sup> DAY OF FEBRUARY, 2010, WITH THE EMERGENCY CLAUSE APPROVED SEPARATELY.



CITY OF VINITA, OKLAHOMA



